2	0230		(C) Partial reconstruction of events follows: Approximately 200330 Mar 71 LZ HA received a bombing of mortar rounds followed by a cannon attack. TOC and Line Co CP were destroyed along with some bunkers on the perimeter. Initial reports from Col. Hathaway to Division reveal 40 US KIA, and 10-11 US KIA. There were 12 enemy KIA. Heavy ground attack believed to be centered around South perimeter and water point with enemy advancing through the tank dump. Ground attack consisted of RPG's, antitank charges, and SAZ. Uncont dustoffs, smoke, and arty illum requested and processed. From 0230 to 0800 the following aircraft were on station at one time or another; Dustoff 55, Dustoff 85, Polio 23, Polio 26, Sabro 54, Hawkeye 20, Helio 41, Helio 02, Shadow 61, Charger 13, Red Baron 35, and Jack Hawk 3. Emergency medical supplies and medical team was inserted from Hawk Hill. Emergency Class 5 was requested from Hawk Hill. All wounded were evacuated by daylight. LZ HA was then secured in by ground. A Co and B Co were told to hold in position. D Co moved to PZ BS 080027. Construction to PZ HA. C Co to be attached to Chu Lai. Nothing further at this time.			Filed	JH
