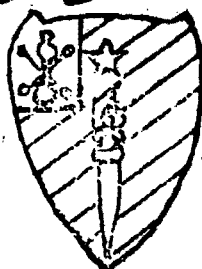
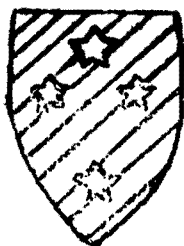

MEMORIAL DAY, FALLEN HONORED

CHU LAI. The Battalion was standing in formation at "Parade Rest". At 0600 the Battalion Executive Officer called the formation to "Attention", as the flag was raised to full staff, then lowered to half staff. Chaplain Black read Psalms 121 and gave a memorial message in which he ended with a prayer. The Battalion Adjutant came forward and read a roster of names from each company of those who have fallen since January 1st:

THE PROFESSIONALS CONTINUE TO STRIKE AT CHARLIE'S RESUPPLY

MAY 14th

Company B found 12 recoilless rifle rounds and 6 82mm mortar rounds.

MAY 16th

Bravo Company's 2nd Platoon while searching through some hootches and a tunnel complex found: 30 82mm mortar rounds, one M-16, 10 C4 granades, 2 NVA packs with medical supplies, 2 NVA ponchos, 3 NVA gas masks, two M 47 magazines, 150 rounds of M16 ammo, 40 rounds M-60 ammo, 50 rounds M-16 ammo, 6 plastic film bags, 3 NVA canteens, one NVA receiver/transmitter radio, 3 boxes of spaghetti and sardines, and one bear-trap which was booby-trapped with a C4 granade.

MAY 19th

Company B's second platoon continued to find the enemy's equipment. This time they found: one SKS, 2 M16s, one US M-1 rifle, one C4 field

LZ PROFESSIONAL BECOMES NVA TARGET

L Z Professional came under a NVA offensive attack 0220 hrs. on May 12. The attack consisted of 62mm mortars, RPGs, and small arms fire. Later on the NVA boldly tried to assault the bunker line, but their attempts were futile. Delta Company who at the time was securing the hill made a sweep of the area from which the main attack had come. D Company found: 20 NVA KIAs with assorted equipment, 6 AK 47s, 2 Soviet made pistols, 2 RPG-7 launchers, 150 Glocm grenades and 10 AK 47 magazines. The NVA in their determined push found out the hard way that the Professionals wasn't about to budge an inch.

CHARLIE'S RESUPPLY (Con't)

phone, 15 62mm mortar rounds, 30 rounds M-60 ammo, 10,000 rounds AK ammo, 2 CS 62mm mortar fuzes, 2 cans of black powder, one pair of NVA boots, assorted documents, 20 feet of alaymore wire, a box of medical supplies, one AK 47 magazine, and 3,000 lbs. of cinnamon which was destroyed.

MAY 22nd

The Third Platoon of B Company found their share of the enemy's equipment: 9 SKS rifles, 2 57mm recoilless rifle rounds, one 60mm mortar round, 19 bangalore torpedoes, 42 Glocm grenades, 10 fuzes for Glocms, and 2 propaganda tapes.

MAY 26th

Company A found a 51 cal. position with overhead cover. In it was found 30 empty casings that had been used only a few days before. They also found one VC KIA who had been a victim of artillery. Later on that day Alpha found in a tunnel one VC KIA who had been killed by small arms and 100 lbs. of rice. Both rice and tunnel were destroyed.

Delta Company came upon a mortar pit. In the area they found 5 62mm mortar rounds and 2 tunnels. Delta blew the mortar rounds and destroyed the tunnels.

As the names for each company were read, three honor guards from each company came forward. Each honor guard carried either a rifle with bayonet, a helmet, or a pair of spit-shined boots. The rifle was stuck into the ground by its bayonet, and the helmet was placed on the rifle butt. The boots were placed in front of the rifle, thus completing the symbolism of the fallen for that particular company. After all companies had placed their honoring symbols, a seven man firing squad came forward, ending the memorial service by giving a 21 gun salute. The "Fallen Professionals" have left us, but are not forgotten by those who now stand.
