**Subject: Financial Statements for Fiscal Year Ending June 30, 1998**

Enclosed are financial statements for the Americal Division Veterans Association excluding the ADVA Foundation and Scholarship Fund. I hope you enjoy reading them and find the information of interest.

In this mailing, you will find details on spending against the budget, a list of all bank account transactions showing the payee of checks written, and a statement showing ADVA's assets.

In summary, ADVA had financial assets of \$69,879.36 at the end of June. Revenues exceeded expenses with a \$4,595 surplus booked for the year. Unfortunately, some of this surplus has already been used in August to settle a lawsuit for approximately \$8,000 with a former officer. (Bernie Chase has handled the details.) Substantially all of the remaining assets held by ADVA are needed to cover the costs of sending newsletters to Life members over their life expectancies.

Speaking from a financial point of view, this was another good year for ADVA and it appears that the organization's financial status should remain quite strong. You can reassure all existing and prospective Life members that the treasury does contain ample funds to easily cover the costs of maintaining those membership commitments in future years.

Hope to see you at next year's reunion in St. Louis.

**Highlights to Financial Statements for year ending June 30, 1998**

**Dues collected** were \$29,225 slightly exceeding budget by \$425.

**Revenues from investment income** were higher than budget by \$633. Higher levels of income resulted from re-investment of non-interest bearing checking account balances and bank certificates of deposit into short-term corporate bond and money market mutual funds.

During the year, ADVA purchased **T-shirts** for \$3,375, which were resold for \$4,305 and result in gross profit of \$930 before postage/ mailing costs. In general terms, considering postage/ mailing and the absorption of some unsatisfactory merchandise, ADVA has successfully realized profits on the T-shirt promotion. (The accounting conventions used here are conservative as the costs of shirts are booked when purchased and revenue is booked when the shirt is sold. ADVA will realize additional profits in the next year when the current inventory is sold. The exact amounts of T-shirt postage/ mailing costs are not isolated as a separate category and are included below in museum expenses.)

**Historical research documents** related to Vietnam era activity for the Americal Division were acquired from the National Archives in Washington DC by Les Hines, transferred onto computer disks and re-sold to members grossing \$878 of revenues. After considering related expenses of \$572, ADVA document sales earned the association a net profit of \$306. This compares favorably to the budget that assumed \$1,000 of net expense for historical research costs.

**Newsletter expenses** were below budget by \$819. Cost of publishing the newsletter averaged about \$4,400 per issue or approximately \$1.35 per copy.

**Operational Expenses**

**Membership and elections** expenses were incurred totaling \$1,797 and were over budget. These costs include \$762 for a multi-year supply of remittance envelopes, printing and postage for ballots and surveys sent to the membership.

**Convention expense** consists of \$2,000 paid to the Southeast Chapter for hosting the Orlando reunion and travel expense allowances for the National Commander, Adjutant, and Finance Officer.

For the year, the **operations of the museum** (excluding T-shirt sales) turned a profit of \$142. The museum grossed \$2,458 (from sale of merchandise other than T-shirts) and actual museum expense (including postage costs for mailing T-shirts) was \$2,589 for a net expense of \$131. Actual spending compares very favorably to a net museum expense budgeted of \$1,555. More details are



shown in the attached statement: ADVA Museum Revenues and Expenses by Month.

National recruitment expense was \$2,324 and over budget by \$774. This expense is constituted of a grab-bag of various initiatives of many individuals and mostly to pay for postage and printing costs. The largest single item within recruitment was \$842 paid to the Army Divisions Association for advertising in various publications with veteran readership. Other items included in recruitment cost can be found on the attached Transaction Report.

### **Officer's Expenses**

Officer's expenses in total were below budget by \$829 and represent reimbursements for postage, supplies, and expenses to conduct business for the organization. Officers are not compensated for personal time.
