Executive Council: Terry Babler; Larry Gelnett; Les Hines


Junior Vice Commander: John Bowley; Vernon Pike; Edward den Braven



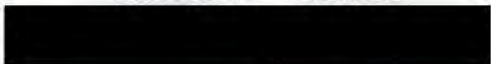
