**Vietnam Vets Network**

This is the eighth in a series of Americal Medal of Honor recipients.

**CAPTAIN JAMES ALLEN TAYLOR**

Rank and organization: Captain (then 1st Lt.) U.S. Army, Troop B, 1st Cavalry, Americal Division. Place and Date: West of Que Son, Republic of Vietnam, 1 November 1967. Entered service at: San Francisco, California. Born: 31 December 1937, Arcata, California.

Citation: Captain Taylor, Armor, was serving as executive officer of Troop B, 1st Squadron. His troop was engaged in an attack on a fortified position west of Que Son when it came under intense enemy recoilless rifle, mortar, and automatic weapons fire from an enemy strong point located immediately to its front. One armored cavalry assault vehicle was hit immediately by recoilless rifle fire and all 5 crewmembers were wounded. Aware that the stricken vehicle was in grave danger of exploding, Capt. Taylor rushed forward and personally extracted the wounded to safety despite the hail of enemy fire and exploding ammunition. Within minutes a second armored cavalry assault vehicle was hit by multiple recoilless rifle rounds. Despite the continuing intense enemy fire Capt. Taylor moved forward on foot to rescue the wounded men from the burning vehicle and personally removed all the crewmen to the safety of a nearby dike. Moments later the vehicle exploded. As he was returning to his vehicle, a bursting mortar round painfully wounded Capt. Taylor, yet he valiantly returned to his vehicle to relocate the medical evacuation landing zone to an area closer to the front lines. As he was moving his vehicle, it came under machinegun fire from an enemy position not 50 yards away. Capt. Taylor engaged the position with his machinegun, killing the three man crew. Upon arrival at the new evacuation site, still another vehicle was struck. Once again Capt. Taylor rushed forward and pulled the wounded from the vehicle, loaded them aboard his vehicle, and returned them safely to the evacuation site. His actions of unsurpassed valor were a source of inspiration to his entire troop, contributing significantly to the success of the overall assault on the enemy position, and were directly responsible for saving the lives of a number of his fellow soldiers. His actions were in keeping with the highest traditions of the military profession and reflect great credit upon himself, his unit, and the U.S. Army.

**ATTENTION!**

In a previous issue of the newsletter, we printed a request by F. Clifton Berry for 196th. Light Infantry Brigade vets to contact him and hopefully supply information for his upcoming book about that outfit. Your Vietnam Editor received word from Mr. Berry that many veterans of the 196th responded with information and photos. He asks that we use the newsletter to publicly thank all the men who provided help. His book, titled "THE CHARGERS" is one of the early titles in the Illustrated History of Vietnam that will be published by Bantam Books beginning in Summer 1987. The books in the series will be paperback with many color photos. The manuscript for THE CHARGERS is complete now, so Berry asks that no other materials be sent to him. Berry said that the official archives are in a sorry state but he was able to reconstruct the chronology of the 196th from activation to inactivation as the skeleton of the book. The individuals who responded with their experiences add flesh and blood to the account.

## A SACRED PLACE ON THE POTOMAC

It is at once the the simplest and yet most moving of all Washington monuments and memorials. And as the Vietnam Vets Memorial nears its fourth anniversary, "the Wall" has become more than just an astonishingly powerful remembrance of the 58,132 who fell in a bitterly divisive war. Indeed, many of the 15 million people who have descended the gently sloping path along the V-shaped granite wall have come not merely as visitors but as pilgrims.

They arrive bearing the flowers, candles and flags traditionally honoring graves and stone slabs that list the names of the dead. But to a degree unprecedented at any other memorial in America, relatives and friends are bringing offerings to their dead, from a pack of Lucky Strikes or a cap spontaneously laid down to carefully framed photographs and handwritten letters of love.

The tradition began in 1982 when the brother of a lost Navy pilot cast a Purple Heart into the wet cement of the walls foundation. Later, someone left scuffed cowboy boots before the 247-foot wall, the first recovered memento.

At first, the National Park Service gathered the abandoned items and stored them in one of its lost-and-found repositories. But none of the items was ever reclaimed. So officials decided to treat the collection, now 4,000 items, as historical artifacts. Now the momentos are "field finds" much like Indian arrowheads or colonial-era potshards found in National Parks. Once collected by Park Service Rangers, the momentos are handled with white cotton gloves, tagged and placed in plastic envelopes or stored in special containers to preserve them for museum display or study by scholars.

Almost everything deposited at the wall, other than fresh flowers and uninscribed flags, is housed in the National Park Services Museum and Archeological Storage Facility in Lanham, Md., a cavernous block warehouse holding 30,000 historical artifacts, including items from Lincolns assination. "We may never understand the phenomenon that brought these gifts about," says curator David Guynes. "But the wall has become a sacred site". We accord these objects respect now and save them as very important sources for future historians to understand the impact of the war."

Agent Orange Update

The battle continues for Nam vets who had their health damaged by exposure to Agent Orange. They continue, without success, to demand disability benefits from the VA for herbicide related ailments. Unable to sue the U.S. Government, they took the chemical companies to court. Two years ago, Dow and six other chemical companies settled the Agent Orange class-action lawsuit against them out of court, by agreeing to pay vets and their families \$180 million. Interest has now raised that figure to nearly \$220 million. But to date, not a penny has been paid to anyone.

The reason that no payments have been made is because an appeal has been filed by some vets who consider the settlement amount paltry and they insist that the case go to trial with a verdict to be rendered by the court. Until the court acts later on this year, no money will be distributed. They could order that the plan be upheld as originally designed or up the ante by the chemical companies.

The original plan would take the \$220 million and allocate a portion of that to medical services for all Agent Orange victims and their families. But the bulk of the funds would go as direct payments to individuals. \$220 million might seem like a lot of money but dont start getting excited over it yet. Cash payments would be restricted to two groups: the totally disabled and survivors of those that have died, an estimated 49,000 people in all. The maximum payment is estimated at \$12,800 to be spread out over a 10 year period. Im serious guys. This means that a vet who is determined to be 100% disabled as a result of Agent Orange, will receive about \$100 a month for that 10 year period. Plus, a vet must have been totally disabled since 1970 or before to be in that \$100 bracket. Those disabled more recently will get less. The families of deceased vets would get a lump-sum payment estimated at \$3,400. The current plan completely rejects the claims of approximately 39,000 wives who have reported miscarriages, 69,000 children alleged to have birth defects, and all claims of partially disabled veterans.

Now heres something that is going to tick off a lot of you men. Approximately 40 lawyers who were appointed by the court to represent the veterans and their families, were awarded \$9.3 million in fees. That \$9.3 million will be subtracted from the settlement fund. Thats approximately \$232,500 for each of them. We all know that a full one-third of the damages is the standard attorneys fee in such contingency cases so naturally some of the attorneys are appealing their awards. lets see, one third of \$220 million is approximately \$73.3 million. Divide that by 40 lawyers and you have a little less than \$2 million per attorney. So thats it men, the lawyers representing your Agent Orange claim against the chemical companies, propose that a dead veterans family gets \$3,400 and his fee is \$2 million to get that for them. Lets hope that the courts render a decision that will show some justice where its definately due.

Regardless of the article I wrote about about the many faults of the current Agent Orange settlement, I advise all vets who believe that their health problems are dioxin related, to seek an examination at a VA hospital. Even though we are aware that no disability claims based on exposure to Agent Orange have been adjudicated in favor of claimants, the examination could help to detect any illness the veteran may have, regardless of origin. If the Agent Orange studies now in progress should produce tangible conclusions, the exam could produce vital evidence in preparation of a claim for disability. It is always prudent to the veteran to claim a disability is service connected as soon as possible. The passage of time will weaken this claim.

## Mr. Dunphy:

I finished reading VIETNAM WAR ALMANAC by Harry G. Summers Jr., copyright 1985, just recently, and I was wondering why the 25th Infantry Division, 3rd Brigade, was not mentioned as being part of the formation of the Americal Division. I was a member of the 25th Div. at a place called LZ Montezuma when the initial forming of the Americal took place in 1967. Task Force Oregon was also formed at this time and many prominent people were there for the formation of both groups. I don't remember the exact date but I have pictures of Gen. Westmoreland and his private plane "Dumbo" and also pictures of Robert McNamara. As I recall, one Brigade of the 1st Cav and one Brigade of the 101st Airmobile was also part of the original Americal Division. Right after the meeting, we were told we could wear the Americal patch along with the "Tropic Lightning" patch. As this was an important part of my life and I know that it did take place, I'm wondering if Mr. Summers did not do his homework very well or if this is another one of those little hidden items that were hidden by the War Department. It may not be very important now but never the less it did happen and I feel that some should know. If you need more detailed information or pictures during that time frame, I can be reached at the address you will find at the end of this letter. I realize that you did not write the book in question but I cannot reach the author and he lists your Association as a reference. If you can furnish me with his address I will contact him personally and correct his error. I would appreciate any help you could give me and wish to thank you for your time and hope you will keep me posted. I was proud to be a member of both the Americal and the 25th Division and still keep shoulder patches from both. My name and rank during that period of time was SP5 Timothy P. Macsay 3rd Brigade, 25th Med Bn and 1/35th 25th Inf Div "Cacti Green".

## A SALUTE TO THE NATIONAL GUARD

This issue of the Americal Newsletter is dedicated to the National Guard.

On September 1, 1939 the armies of Nazi Germany crossed the borders of Poland and Europe soon became engulfed in the conflagration that is known as World War II.

However, the part of World War II that the Americal became embroiled in actually began in July of 1937 when the Japanese Army in Manchuria, it had occupied this province for many years, crossed the Hun River into Liaoning Province, precipitating the Sino-Japanese War. From this point the Japanese War Machine rolled across China, north to the Aluetians, west to Wake and Guam, and south through the Solomon Islands where they were finally halted on Guadalcanal.

September 1, 1939 found the United States with a standing army of only 190,000 men. The mainstay of the reserve forces that could be called upon were eighteen under strength National Guard Infantry Divisions and other units scattered throughout the United States, Hawaii and Puerto Rico.

The call to Federal service began for the National Guard on February 16, 1940 when the 45th Division was Federalized. This division consisted of units from Arizona, New Mexico, Colorado, and Oklahoma National Guard. "Call-Up" continued through 1940 and by February 24, 1942 when the 43rd Division was the eighteenth and last Infantry Division to enter Federal service.

In March of 1940, even after the first National Guard units were Federalized, the Congress of the United States whittled away at defense spending. \$12,000,000 that had been earmarked for Alaskan defenses was eliminated and the entire Air Force was allowed only 57 aircraft--not additional, just replacements.

By now Czechoslovakia, Bohemia and Hungary were under the German boot.

Finally, on September 16, 1940 Congress approved the Selective Training and Service Act. All men between the ages of 21 and 35 were required to register. This Act authorized a training period of twelve months for 1,200,000 Selectees and 800,000 Reserves.

Many of the first men inducted under this Act were used to "flesh-out" the National Guard units.

All of the National Guard Infantry Divisions that had been Federalized were square divisions. They each contained four infantry regiments and supporting units. In late 1941 an Army decision was made to streamline all of these and convert them to triangular divisions. This process also did away with Brigade Headquarters, shortening the chain of command and making a division more manageable.

The infantry regiments that were cast off during this process suffered various fates---some went to Africa, some went to Italy and then Europe, the Caribbean, the Aleutians, and three never left the States.

As all Americal men know, three of these cast off regiments met overseas and formed the Americal Division. This was the only new division formed from other National Guard units---also the only Division to serve without a number!

At least three tank battalions, taken from Georgia, Minnesota, and California National Guard units

were sent to the Philippines in 1941 and became P.O.W.'s with the fall of Bataan and Corregidor.

One artillery unit was at sea on its way to the Philippines when the Japanese struck Pearl Harbor. This unit was diverted to Java to assist the Dutch. With the fall of Java these men became P.O.W.'s and some of them were destined to help build "The Bridge on the River Kwai"---few returned to their homes at the end of the war.

Nine of the original National Guard Infantry Divisions saw action in Europe---the 29th Division from Virginia, Maryland, Pennsylvania and D.C., landed in France on D Day---. The remaining nine division, plus the Americal, saw action in the Pacific.

Is it not fitting that we give a big "THANK YOU" to the National Guard for a job well done? These units, many with a long history of answering our Country's call to arms, (the history of the 182nd Infantry dates back to 1636) came through again in one of our Country's darkest hours.

Dear Bill;

I enjoyed the short telephone conversation that I had with you last Monday. As I mentioned, I am signing up a new member for the Americal Association, Howard Travis from Bourne, MA formerly from Saxonville. He was with the 101 QM from the National Guard days. I told him to send the application to your home address. I took Ed Menz with me to visit Howard. Ed isn't in very good health and I am praying he will recover. I would appreciate it if you would drop in on him sometime.

About New Caledonia - spent three weeks there and ten days in Australia, three days in Brisbane and seven days in Sydney. Visited some New Caledonian friends that are living in Australia since the political strife in New Caledonia.

The people in New Caledonia were very pleased to see me because I did not go there in 1984-85 due to the civil disturbance. At the moment the situation is in limbo but could explode at any time. It is too bad that such a beautiful island with fine French people should be troubled with communistic problems. I stayed the whole three weeks with a New Caledonian family at Motor Pool, (familiar to you ex G.I.?) Their home was on a high hill overlooking the sparkling sea on one side. The other side faced the towering Mt. Kogi and Mt. Dore and Mt. Moui in the distance. A short walking distance and in plain view was the Catholic Church that the U.S. Military built for the people of New Caledonia. At night the dark blue sky was covered with huge stars including the Americal stars -- the Southern Cross. Please Bill believe me when I say that I am enchanted with New Caledonia.

I spent two days and one night visiting people Moindou. From Noumea to Moindou highway # 1 passes through the villages of Dumbea, Paita, Boulapari, La Foe and then into emptiness -- yellow grass rippling in the wind, from the highway to the mountains, as far as the eye can see -- white trunks and gray green foliage of the Niaouli trees. To me it was the silence of anguish from the hectic military days of World War II. My Moindou friends rounded up a good number of people for a huge banquet dedicated to me. To eat lightly would have been an insult to them. The tables were loaded with venison, huge pyramids of oysters, large red shrimp, huge crabs with enormous claws, cooked vegetables, salad, cake, ice cream and of course plenty of wine and choice of whiskey. I believe it took about three hours to finish the meal and talk about World War II days. You know the New Caledonians of World War II days adore the Americans.
