

VIETNAM NEWS NETWORKThis is the twelfth in a series of Americal
Medal of Honor recipients.

THOMAS J. McMAHON K.I.A.

Rank and organization: Specialist Fourth Class, U.S. Army, Company A, 2nd Battalion, 1st Infantry, 196th Infantry Brigade. Place and date: Quang Tin province, Republic of Vietnam, 19 March 1969. Entered service at Portland, Maine. Born 24 June 1948, Washington D.C. Citation: For conspicuous gallantry and intrepidity in action at the risk of his life above and beyond the call of duty. Sp4c. McMahon distinguished himself while serving as Medical Aid Man with company A. When the lead elements of his company came under heavy fire from well fortified positions, 3 soldiers fell seriously wounded. Sp4c. McMahon, with complete disregard for his safety, left his covered position and ran through intense enemy fire to the side of one of the wounded, administered first aid and then carried him to safety. He returned through the hail of fire to the side of the second wounded man. Although painfully wounded by an exploding mortar round while returning the wounded man to a secure position, Sp4c. McMahon refused medical attention and heroically ran back through the heavy enemy fire toward his remaining wounded comrade. He fell mortally wounded before he could rescue the last man. Sp4c. McMahon's undaunted concern for the welfare of his comrades at the cost of his life are in keeping with the highest traditions of the military service and reflect great credit on himself, his unit, and the U. S. Army.

Some background: U.S. Representative Tom Ridge, 41, is an Erie Republican currently serving his third term as a member of Congress representing Pennsylvania's 21st Congressional District. A Harvard College graduate, he served with the Army in Vietnam from October 1969 to July 1970, when he suffered a ruptured appendix, with the rank of Staff Sergeant as an advisor to a South Vietnamese infantry platoon. He was assigned to Company B 1/20 11th Light Infantry Brigade in I Corps outside of DaNang. P.S. He didn't like the movie.

It is possible to request photo copies of Americal Division Operational Reports, Lessons Learned (OR-LLs) free of charge from: Department of the Army, US Army & Joint Services Environmental Support Group, [REDACTED] Washington, D.C. 20006-3868.

I requested these giving the two units I served with while in the Americal Division in Vietnam besides dates of engagements I particularly remembered. These reports are detailed giving the company sized units involved complete with casualty figures on both sides. Grid coordinates, captured material, planning considerations and details besides summaries are all included. These reports are now stamped "unclassified" from their original "confidential" and should be of use to anyone writing books or articles. These reports helped me put my combat experience in perspective to the overall activity of the Division. Although the writing style is dry and factual the excitement of having participated in the events described jumped at me from the pages as I remembered the details. The Operational Reports were issued quarterly and were distributed to the various Army schools besides Commanding Generals of the Continental Army Command and Combat Development Command.

The US Army & Joint Services Environmental Support Group was unable to locate the Combat Operations After Action Reports (COAARs) turned in by the Americal Division during Vietnam service. I wonder if these may exist at another location since the information contained in them should be extremely interesting. Perhaps other veterans could send details.

For those veterans who have not received their awards, a request letter to the following address along with copy of DD Form 214 will result in the awards be sent free of charge.

Thank you so much for printing my letter. I had letters and a call from two boys. One went over on the same boat with Jimmy but was in a different Company and does'nt remember him. He's from Rhode Island. The other is from New Jersey. They had read your letter. The one Joe Buss, from Lincoln, Rhode Island was in C Company. Jimmy was in A Company. He sent me a copy of a page from the Americal Newsletter, Nov.-Dec. 86'. It was a copy of the Valorous Unit Award which was a lot like the letters from his officer but it was good to read. I can believe that the boy from Company A did not return, said that Jimmy would not leave his machine-gun even though he was wounded. Was missing for a week so identification must have been removed. His face and everything was okay, so we know he was taken care of but had no identity.

Am sending you an article out of our paper. I saw the "Wall". My daughter and I took pictures. Am writing to the boys. Hope they can recognize a couple of those guys.

Thank you for your bother. If I hear anything, I'll let you know.

ADVA member Mike Standerfer who made the famous walk from his home in Florida to the Alamo in Texas to bring attention to the POW-MIA issue has informed me of a major effort being made this coming Veteran's Day in Washington, D.C., to once again bring national attention to our still missing comrades. On Friday, Nov. 6th., there will be a candle light parade at the Lincoln Memorial. The following day they will march to the Capitol Bldg. for a rally on the steps. On Sunday there will be a POW-MIA prayer service at the Lincoln Memorial.

The parade committee plans to assemble 2400 pairs of boots to depict the men who are still missing. The boots will be secured to boards and carried by the vets at the parade and rallys. If they are sucessfull in obtaining that many, I'm sure that the effect will be noteworthy to the news media. They're always present in great numbers in the Monument area on Vet's Day so this will be a great opportunity to spread the word.

This event is being sponsored by the The American Foundation For The Accountability Of POW-MIA's under the auspices of the National Vietnam Veterans Coalition (a group of 45 organizations with 300,000 members).

Also from Mike Standerfer we have information on "The Last Patrol", a group of Vietnam veterans who want to call attention to our POW-MIAs. They are currently enroute from the Alamo in San Antonio to the Vietnam Memorial in Washington. They departed on Labor Day and plan to arrive at the outskirts of D.C. on 11-6-87. There they will wait until the other "Patrols" have arrived from all over the U.S. and then stage a massive display of unity as they march to the "Wall".

The march is being led by well known Nam vets, Michael Martin and Tim Holliday. They are endorsed and supported by the Texas State Council of the Vietnam Veterans of America. Along the way of their 1600 mile march, they hope to organize veteran voter registration and establish a support network for all Vietnam Veterans and their families. The support network endeavors to offer alternatives to deal with the problems that Nam vets suffer in disproportionate numbers such as suicides, divorces, drugs & alcohol, unemployment, incarceration, and severe mental and health problems.

A hand-out by the VVA states, "Certainly, this is a very ambitious endeavor. America's history reflects all sorts of ambitious endeavors when brave souls have dared to go against the odds. We have chosen to depart from the Alamo to dramatize this theme. We want America to recognize that the same sense of duty and valor still exists. Not only will we go the extra mile, we'll go 1600 extra miles to make a point. A "grunt" can walk forever. Remember the Alamo! And remember the forgotten man."





ARTICLE V

NOMINATIONS AND ELECTIONS

Section 26: National Officers

- a. A nominating committee comprised of not less than five(5) members appointed by the Commander and approved by the Executive Council.
- b. The annual election of officers shall be held between May 1st and July 31st of each year.
- c. The nominating committee shall report to the assembly at the third General Meeting prior to the Annual Reunion Conference its recommendations of officers for the Association.
- d. Further Nomination for elective office may be submitted to the National Adjutant not later than the third General Meeting prior to the Annual Reunion. - g. Members who decline a nomination must do so in writing and will be eliminated from the ballot.
- h. No member will be allowed to nominate themselves nor will they be allowed to accept more than one nomination.
- i. The plurality of votes cast by the members voting in the election will decide the election.

PLEASE NOTE: Any active member who would like to seek a National Office please refer to the above ARTICLE V, NOMINATIONS AND ELECTIONS, Section 26:, Paragraph d.
