MAY THEY REST IN PEACE

164 INFANTRYGRANNY REMEMBERED

As most of you know, John "Granny" Greenhalgh died of heart failure a few weeks ago. Granny was given a DAV funeral with full military honors at Black Hills National Cemetery on Friday February 26.

Granny's many contributions to Chapter 3 are well known, he was Golden Rodent of Trench Rat Dugout 369, a member of the Chapters Executive Committee, and Color Guard and Firing Squad Officer at the time of his death. Perhaps he will be best remembered for his role as Santa Claus at three of the last four Chapter Christmas Parties, at Rushmore Mall, and at many charity and hospital Christmas events. Granny truly loved playing Santa, his heart and soul were in it and kids of all ages KNEW it.

What is less known of Granny is his wartime service - because he didn't talk about it much. In December of 1940, at age nineteen, Granny enlisted in the South Dakota National Guard and he served in the AMERICAL DIVISION from the time it was organized until his discharge in 1945. During his service he was involved in many memorable battles of the Pacific "Island hopping campaigns" including Guadalcanal, Bougainville in the Solomon Islands and the Philippines. On Bougainville he suffered through a bad bout with malaria. Among his awards and decorations were the Combat Infantry's Badge (his most cherished), the Bronze Star, Philippine Liberation Ribbon and World War II Victory Ribbon.

John "Granny" Greenhalgh did his part for his nation and for his fellow veterans - and more. Granny dead at 66. Gone but not forgotten

Joseph T. Alleckson, a retired transportation manager in the wholesale paper industry, passed away at his home in Long Beach, CA on February 22, 1988. He was 67 years old.

He had lived in Long Beach since 1945 and he retired in 1975.

Alleckson was a native of Williston ND. In World War II he left Williston with 164 Infantry, North Dakota National Guard, when it was Federalized. The 164 Infantry became part of the Americal Division in the South Pacific.

He was a Life Member of the George Wallace White. VFW Post #1746, a member of Amvets Post #48, a member of Paramount Elks Lodge 1804, and he was also a Life Member of the Americal Division Veterans Association.

Alleckson is survived by his wife Audrey, a sister Stella and a number of nephews and nieces.

101 QUARTERMASTER

A funeral mass with Military honors was said on February 23rd for Francis J. Connelly, a life member of the Americal Division Veterans Association, who died at 80 after a period of failing health. His military career began in 1928, when he enlisted in the horsedrawn artillery, 101 st Ammunition Train, 26 Div, MNG. In 1941 he was inducted into federal service and he commanded the maintenance troops of Task Force 6814. He served as an ordnance officer with the Americal Division and with other ordnance units in the South Pacific. While in New Guinea, he received a commendation from the Commander of the Sixth Army after leading the unit that established the all-time record for assembling combat vehicles in that theatre. Returning to the U. S. in 1945, he served as assistant director of maintenance, First Service Command, and commanding officer of the Boston Ordnance Shop until his discharge in 1946 with the rank of Major. On retirement he was awarded the rank of Lt. Col. He resumed his position with the Military Department, and upon finishing first in a civil service examination, he was promoted to Superintendent of Armories. Responsible for much of the reorganization of National Guard maintenance shops throughout the Commonwealth. He received a commendation from the then adjutant general of Massachusetts. He retired in 1978, having reached the mandatory retirement of 70, after a career with the MNG that spanned 50 years.

Mr. father rarely spoke of his service, and never of his accomplishments. Once in a while he would mention Australia, New Guinea, New Caledonia, or Woodlark Island. He maintained friendship and correspondence with Rev. Frederic Gehring, the "Padre of Guadalcanal," and was of course, aware of the passing of so many of his generation and with them the memory bank of that war in those far-away jungles. He read with interest every issue of the "Americal Newsletter", and saved many issues for review and doubtless, remembrance.

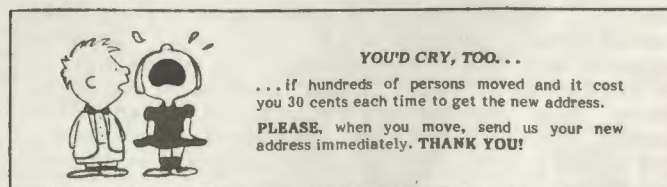

THE BATTLE FOR HILL 260

BATTERY A 246 FIELD ARTILLERY

Dear Sir;

I read with interest the account of the OP tree on Hill 260 in Bougainville.

My men of Battery A of the 246 FA manned this tree. I commanded Battery A during our campaign on Bougainville.

The O.P. tree was on an outpost, beyond the front lines, that was manned by the 182 Infantry (G Company). They had a platoon on the Hill to guard the tree. I'll never forget the first time I climbed the tree (Banyun) after the engineers had finished it. Being 125 feet tall it gave us excellent observation of the Torokina River and many thousands of yards beyond. We were tied in with Hill 270 (OP7) and Hill 309 (OP6)--Hill 260 was OP 5. The patrols that went out beyond the Torokina River would radio us when they had enemy contact. They would explode a colored smoke grenade on their flanks, which we would spot and by sound they would adjust fire on the enemy positions.

A 500 yard safety factor was always added. (We always appreciated the covering fire the artillery gave us. These patrols always had an artillery forward observer and a radio man with them. Ed note.)

I was up in the tree for five days observing and directing fire until relieved by 2nd Lt. Earl E. Excell and five men from my battery on Friday afternoon. I had seen Jap activity along the Torokina River to our direct front before I left the tree. The Japanese attacked Hill 260 on early Saturday morning. I talked with Lt. Excell, during the attack, before he was killed. The telephone line was cut by fire and that was my last conversation with him.

The Commanding Officer of the 246 FA Bn sent me back up to keep direct fire on the Hill. I remained there for fourteen days--until the 182 Infantry could secure the Hill. I had with me as a radio and telephone operator, Sgt. Leonard (Pappy) Mejia with whom I still correspond. Pappy now lives in Kansas City, KS.

The executive officer of Battery A, 246 FA, was Gilbert Rhodes fired many rounds of 105 shells during Jap control of the Hill. He and I have been close friends since the War. He left Battery A to become CO of Headquarters Battery. The Japs did not abandon Hill 260 but were driven off by artillery and Infantry mortar and rifle fire--also air bombing. I went back after the Hill was secured, with a Catholic Chaplain, to find my men at the base of the tree. It was truly a mess. I admired the Chaplain who went with me. I still have a panoramic photo view of the entire area in front of Hill 260. It covers from Mount Bagana (active volcano) on the left across the Torokina River to the ocean on the right. I feel fortunate to have it and I would like to give it to the Museum. It was damaged a little by water when my bag got wet. Again, I appreciate your dedicating the March-April issue of the Americal Newsletter to veterans of Hill 260 and the "Million Dollar Tree" for the part that the took in that battle that occurred forty four years ago.

I served in the Americal Division from the time of it's activation on New Caledonia until the War was over. I went into Japan with the occupation force and spent five weeks there before returning home. I stayed in the Army Reserve after the war and completed twenty years of service of which I am proud. I was County Agricultural Agent with the Extension Service for 30 years.

I admired the 182 Infantry for their hard fighting during the siege of Hill 260 and praise those many men who lost their lives.

The men from the 246 FA who gave their lives manning the outpost on top of the 'Million Dollar Tree' on Hill 260 were; Lt. Earl E. Excell, T/4 Clarence Fulcher, T/4 Barney O'Neal, Pfc. Hardy Robson, and Pfc. John Lamlen.

Again, I enjoy your Americal Newsletter very much and appreciate the good work of the entire staff.

BATTERY A 246 FIELD ARTILLERY

Dear Sir;

I am writing about that article on the "Million Dollar Tree" on Hill 260 in Bougainville. That O.P. was manned by Battery A, 246 Field Artillery.

I was a radio operator for the Forward Observer that was with the 182 Infantry on Hill 260. I remember that Battery A lost one Lt. and four enlisted men. I can't recall their names because they were all new replacements. I do know who can fill in all the details and that is Ltc. James Watson. (See previous letter Ed) In fact, we were in the same fox-hole. I had a 12 gauge shot gun. He was a damn good Captain! He was a man that would not send his men to do anything that he would not do himself.

I am enclosing a commendation and a citation if you care to print them. I am not bragging--I am proud that I served with the Americal from the time it was formed in New Caledonia until Cebu in the Philippines. I left the unit on Cebu on August 14, 1945 and we stopped at Pearl Harbor right on V.J. Day.

Keep up the good work on the Newsletter.

SUBJECT: Commendation.

TO : The Officers and Men, "A" Battery, 246th Field Artillery Battalion. (Thru: Commanding Officer, 246th Field Artillery Battalion).

The tradition of the Field Artillery, from the days of the brass cannon, demands that when our Infantry is threatened, the artillery stays with its guns and shoots, despite any enemy action. Today, you have all upheld that tradition in a manner to bring additional glory to this age-old tradition.

With a small outpost garrison of the 182nd Infantry out off and penetrated by the advance elements of a Japanese attack on our positions, your actions in continuing the accurate serving of your guns, although under intense enemy shell fire the while, shall go down in the annals of history as a deed that shall be listed, forever, in the records of this Arm. Your fire, and that of your battalion, in close support and barrage missions, placed a ring of steel around the threatened outpost and, to a marked extent, prevented an all-out attack of our lines.

I have served in the artillery through two wars. I have seen many brave deeds by battalions of artillery. Your action today will always be paramount in my memories and I consider it a great privilege and honor to serve with men like you.

TO ACCOMPANY ANNOUNCEMENT OF THE BRONZE STAR MEDAL AWARD
PUBLISHED IN GENERAL ORDERS NO. 124 THIS HEADQUARTERS

5 August 1944

TECHNICIAN FIFTH GRADE LEONARD MEJIA

Leonard Mejia, 37015579, Technician Fifth Grade, Field Artillery, United States Army, for meritorious achievement in connection with military operations against the enemy at Bougainville, Solomonic Islands, on 11 March 1944. During operations against the enemy at Bougainville on 11 March 1944, Technician Mejia, a switchboard operator, volunteered to aid another men in the laying of two telephone lines across approximately three hundred yards of open terrain where enemy 75mm and 150mm shells were landing. Later he volunteered as a radio operator to accompany an Infantry Battalion to secure Hill 260, and when casualties were suffered he aided in their evacuation over rough jungle terrain to a rear medical aid station. His courage in the face of enemy fire and his devotion to duty was an inspiration to the officers and men of his unit.

246 FA GRASSHOPPER PILOTS

Dear Jim;

Enclosed is a reproduction of a letter I sent to Victor G. Landers, 57th Eng., Alturas, FL, on Nov 14, 1984 referring to an excellent story appearing in the Sept-Oct 1984 issue of the Americal Newsletter. The picture of that issue was of 'The Million Dollar Tree' on Hill 260 so it was with great nostalgia that a similar picture should appear on the Mar-April 1988 Newsletter. Especially since I see that small speck in the sky to the left of the tree trunk. Who knows?--If you could spot a #6 on the side of that observation plane it may be me--or Killbrough, Samans, Jones, Cochrum, Lynn, Bruce or Parks.

A sad recollection of that historic period was the loss of S/Sgt. Fred Shemas who lived in DuBois, PA just 210 miles from my home in Clearfield. Fred was with one of the assault companies of the 182 Infantry on Hill 260. Most of the Company were killed or wounded. Fred being one of the wounded. I took Fred for a flight over the area shortly after the action to show him the devastation.

As you know, the main thrust of the Japanese was in the area between the 164 Infantry and the 37 Army Division. To give the 37th Div. some relief after the action, units of the Americal were used for patrol duty in their sector. Fred commanded one of these patrols in the vicinity of the Numa-Numa trail where they were ambushed and the entire patrol was lost.

Victor;

Enjoyed your story in the October issue of the Americal Newsletter.

Our our tenures had some parallels that finally converged in the Americal. I entered the Army with a Pa NG regiment (103) which was converted to 155MM guns and trained at Camp Shelby, MS with the 37th and 38th Divisions. I was a S/Sgt., chief of gun sections.

We migrated to Camp Sutton, NC --Camp Kilmer, NJ -- Northern Ireland and England where I departed for OCS and Observation Pilot training at Fort Sill. OK in April 1943. After OCS and flight training, I ended up in New Caledonia in January 1944 and from there assigned to the 246 FA of the Americal along with the other grasshopper pilot, Marion (Junior) Parks from Muncie, IN.

I also had climbed to the top of Hill 260 with Gen. Slocumb, FA Commander, and party prior to the Jap attack. On the day the Japs dislodged the platoon of Infantry and killed those in the tree OP, and not being aware of this action, I came winging around the Torokina side of the hill. Hearing .30 caliber machine gun fire (Jap MG was much more rapid) and thinking, 'Boy we're giving it to them now.' But looking back, I saw tracers ripping past my tail, so I departed from there as fast as possible. Later I learned of the Japs taking Hill 260, capturing one of our MG's, and nearly doing me in.

Some of we Cub pilots were on Cebu (west of the island with the guerrillas) two days before the invasion. We adjusted naval gun fire on the beach area below the city and later used the boulevard in front of the capitol for our landing strip. Shelled off of there by Jap 20mm fire from the hills above, we took the Cubs to the (former) Jap landing strip on Mactan. There we saw the monument commemorating Magellan, fortunately missing the mines on the strip which you mention.

Even though I had 138 points, Gen Slocumb would not allow any artillery officers to be rotated--he was all heart--. So I made the trip to Yokohama, Japan.

My wife and I have spent the past three winters in Florida and I have e contacted many Americal vets. They include Millard Turner, Louis Foss, Alfred Gutttag, Tom McMurray and many others.

The story on 260 generated a lot of mail and I have learned a great deal about different units that were involved. How about something from the 57th Engineers that built the platform on the 'Million Dollar Tree'?

The 182 never lost Hill 260--they were pushed off of the lower slope but held the higher slope. The 'Tree' stood on a narrow ridge between the two slopes. This prevented a full scale attack from the higher slope and the steep sides of the lower slope made attack very difficult. It took a lot of help to regain it.

At the request of Paul Paturel, President of the Americal Museum in New Caledonia, it was voted at the last meeting of the Executive Council, to set up a trust fund in the ADVA treasury to receive donations for the Museum in New Caledonia. This was done so donation could be sent in one check in order to avoid the \$10.00 per check tax. The Council also voted \$100 to start the fund.

The following is a background on Paul Paturel and the Museum followed by a notice as to where to send donations.

INFORMATION; Paul R. Paturel

Paul R. Paturel was born in Belfort, France and has been living in New Caledonia since 1971. Founder and president of the Americal Museum Association in November of 1985 with Charles Pelletier, born in Noumea, as vice president.

Both men have given all their spare time for several years in search of material on the sites of the old camps of the Y4US troops based in New Caledonia. The Association has 50 members. There are five Americans--ex GI's--Lee Lawrence, Kenneth Joop, Emory C. Lavallee, Bertrand Leveille and Bill Barney, living in New Caledonia and they are Honorary Members. Every year, on the 12th of March, as commemoration ceremony is held and flowers are placed at the Poindimie Memorial.

New Caledonians have kept a very good souvenir of the 'American Era' on the territory. Because of this, Paul L. Paturel decided that in homage to the ex-combatants of the Pacific war a memorial should be built at Poindimie. It would be a Quonset type building where material of that age could be displayed. Financing of this project is entirely private. Paul Paturel has invested all of his savings (\$70,000) this represents many years of work. There is still more to be accomplished (walls, sanitary, blocks, electricity, offices accommodations etc..) \$40,000 is still needed to finish the work.

WORLD NEWS BRIEFS

PROBLEMS FOR FRANCE - Hooded Melanesian separatists man a roadblock on tracks leading to tribal villages in the Canala region of New Caledonia yesterday. Separatists holed up in a cave on the island of Ouvea have held 15 policemen for 12 days and another eight people for a week. French Interior Minister Charles Pasqua rejected a demand by a separatist that the government name an envoy to mediate Melanesian self-determination on the overseas territory.

In the event that you have not read of the recent unrest that is going on in New Caledonia a few of the news items follow;

Boston Globe April 30, 1988;

Noumea, New Caledonia--A French farmer acquitted in the slaying of 10 Melanesian separatists was killed yesterday, the first European settler to be slain in a week of violence in this French Pacific territory.

French settler Jose Lapetite, 31, was fatally shot on his farm on New Caledonia's west coast, bringing the death toll to seven since a group of separatists attacked a police station on the island of Ouvea April 22.

The six other victims were military police or Melanesians. Authorities are still seeking to free 23 policemen taken hostage on Ouvea by the Melanesian separatists attackers.

Yesterday, the separatists released a hostage and ordered him to negotiate with French authorities.

NEW CALEDONIA Con't

The attack on the police station was aimed at blocking elections for regional assemblies that was held on April 24, along with the first round of the French presidential elections.

The elections were carried out despite some disruptions, and were won overwhelmingly by the party aligned with conservative Premier Jacques Chirac. The separatists are demanding that the results be voided and that negotiations begin on independence.

Boston Globe May 1, 1988

Noumea, New Caledonia--A French Navy vessel opened fired on a beachfront encampment of about 30 armed Melanesian separatists in a marked escalation of France's military to defuse the deepening crisis on the South Pacific territory.

No one was injured in the naval barrage, which a spokesman for the French High Commissioner said was provoked when the separatists opened fire on a land patrol of French paramilitary troops.

Los Angeles Times May 2, 1988

Noumea, New Caledonia--Melanesian separatists yesterday called 22 French paramilitary troops that they have been holding for 10 days in a heavily fortified cave "prisoners of war."

The separatist leaders called on the United Nations to send an independent commission to investigate what it calls 'French colonial war'.

The separatists decided to call their French hostages 'prisoners of war' only after the French government labeled the separatists as 'rebels'.

Prime Minister Chirac is considered a conservative and in favor of New Caledonia remaining a French colony--as the Europeans and many of the Melanesians prefer. President Mitterand, whose background is Communist leaning, would negotiate with the separatist, who call themselves 'Kanak Socialist Nationalist Liberation Front', and perhaps set New Caledonia up as a independent nation.

The leaders of this separatist group have been trained in Libya and their ambition is to set up a Communist state in the Pacific Ocean.

Premier Chirac ordered the stronghold on the island of Ouvea stormed. It was. Most of the separatists were killed but the hostages were freed.

Premier Chirac and President Mitterand were in a run off election for President this past week and Mitterand was the winner. Chirac has offered his resignation. New Caledonia will have to wait now to see what the President will do about any continued unrest.

Today is May 11, 1988--the one hundredth (100) birthday of Irving Berlin. Mr. Berlin's family migrated to the United States from Siberia when he was very small and he worked his way up the ladder of success. As you know he wrote many patriotic songs. He was once asked, "Are you for your country when it is wrong? His reply--when we start making mistakes and doing things wrong, I'll resist it all I can, but I'm still all for my country and there comes a time when you have to stand up and shout about your patriotism--"If this is flag waving, do you know of a better flag to wave?"

COVER STORY

GENERAL ARTHUR E. BROWN, JR.

General Arthur E. Brown, Jr. will be the guest speaker at the Americal National Convention to be held in Carlisle, PA on June 9, 10, 11, 12, 1988.

General Brown was commissioned in the Infantry upon graduation from the United States Military Academy in 1953.

Following completion of the Airborne, Ranger and Basic Courses at the Infantry School, General Brown reported to his first assignment as a Platoon Leader in Company A, 508th Parachute Infantry Regiment, Fort Campbell, Kentucky.

Since then, he has served in Airborne, Light and Mechanized Infantry units, completed two combat tours, and commanded at every level from company through brigade in Germany, the United States and Vietnam. He commanded a rifle company of the 60th Infantry at Fort Carson, Colorado; the 1st Battalion, 52nd Infantry of the 198th Infantry Brigade, Americal Division in Vietnam, and the 1st Brigade of the 1st Infantry Division at Fort Riley, Kansas. He served as Assistant Division Commander of the 25th Infantry Division in Hawaii and he was also Commanding General, Army Readiness and Mobilization Region IV at Fort Gillem, Georgia.

In his service with the Americal Division, General Brown assumed command of the 1st Battalion, 52nd Infantry in September 1969. He served with that unit until February 1970, participating in heavy fighting against North Vietnamese regulars in the northern provinces of Vietnam. In addition, he served the Americal Division as its Liaison Officer to the III Marine Amphibious Force at Da Nang. During these assignments, General Brown earned the Silver Star, two awards of the Distinguished Flying Cross, the Bronze Star Medal for Valor, and multiple awards of the Air Medal. He won the Combat Infantryman's Badge during a previous Vietnam tour as an advisor.

General Brown has held operations and training staff positions in the United States and abroad, to include Executive Assistant to the NATO Military Committee, and as a Division Chief and Executive to the Deputy Chief of Staff of Operations and Plans, United States Army.

A graduate of the Command and General Staff College and the Army War College, General Brown holds a Master's Degree in Public and International Affairs from the University of Pittsburgh. He was Assistant Professor of Military Science at Florence State University in Alabama, taught military strategy at the Army War College and served as the Deputy Superintendent of West Point.

Immediately prior to his present assignment, General Brown served four years as the Director of the Army Staff. On 24 June 1987, General Brown became the 20th Vice Chief of Staff, United States Army.

General Brown and his wife Jerry are the parents of three children. They currently reside at Fort McNair in Washington, D.C.

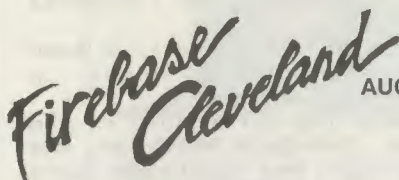

The news clippings from the east coast newspapers continue to arrive from our comrades living out that way. I appreciate all you men who took the time to clip and send them to me. One even appeared here in my local St. Louis newspaper today. Seems that former President Jimmy Carter's wife has come out of the woods to support Jane's endeavor. She thinks that the unforgiving Nam vets are a minority and most citizens are ready to let her acts of treason be forgotten. Forget never!!! I have confidence that the Nam vets on the east coast and those that support us, are going to make it hot for the Benedict Arnold of Beverly Hills if she continues to try filming. As for Mrs. Jimmy Carter, we are'n't forgetting that her husband pardoned the draft dodgers from the Vietnam War, so I'm not surprised that she's gone left wing.

So boys, let's keep the heat on. No retreat!! No surrender!!

Under pressure from veterans groups and mothers of soldiers missing in action, the city council of Holyoke, Massachusetts voted 11-4 to declare Jane Fonda "persona non grata" in their town. Dear Ron;

Thanks so much for the help in trying to get my old unit back together for a reunion. As I promised you, I would let you know what we've done so far so any of the other ADVA members may wish to try also.

First of all it helps to know a computer programmer or to have a P.C. to keep file of all the names and information. The next thing is to get a list of names and addresses as well as social security numbers if possible. It's easier since 1969 when the Army went to SSAN rather than service numbers. I'm still working on different ways to get the names and numbers. So far I've written to the National Archives which for a small fee is sending me all the general orders for my company from 67' to 72'. These orders will be for the decorations etc., but will have names and numbers that we'll feed into the computer. We've also been trying to locate the unit rosters. In our case, the Archives don't have them but the Records Center in St. Louis may. After I get a sizable amount of names, we'll print out a computer list. This will go to the V.A., attention of the privacy officer with a request for him to forward forthcoming correspondence to these individuals. In our case with so many names, 1000 plus, they will tell us how many they can locate, or find the last address on file. I'll then have a flyer printed up (good thing I'm a printer), give the V.A. a stamped envelope and hope for a good return. Hopefully, those that respond will furnish us with more addresses and we'll end up with a reunion in 1989 in Chicago.

If anyone else has some suggestions, I'd appreciate it. This is only one company from Vietnam, yet I think it would be possible in the future to get names for the entire division and get a mailing out. I think the response would be good. It's something for the ADVA to investigate.

I don't know how much this is going to cost yet. That's why I called you about the bulk rate. The idea of the dollar for the forwarding is also a good idea depending on how funds go.

The reason for the privacy officer at the V.A. is to keep the anonymity of those who wish. I know of a lot of guys that don't wish to have anyone bring up the war and I respect that. I do know that there are a lot of men out there who would like to know of the ADVA and become part of it, and in the case of a unit reunion, get together again. That's why I'm doing it.

Legislation authorizing the construction of a statue at the Vietnam War Memorial in honor of the approximately 10,000 women who served in Vietnam has been introduced in Congress as bill S.2042

The introduction of S.2042 came after the Commission of Fine Arts last October defeated a proposal by the Vietnam Veteran Women's Memorial Project to add a statue of a female veteran in the vicinity of the "Wall".

This legislation, if passed, would direct the Secretary of the Interior to select a suitable site.

The legislation also states that the cost of the project (\$1.2 million) shall not be borne by the United States government or the District of Columbia. Private fund raising is underway.

I urge you to contact your elected representative and voice your approval or disapproval.

GUADALCANAL CAMPAIGN WAR MEMORIAL FOUNDATION
An Up-date Report

We are pleased to report that the Foundation (headed by Dr. Robert Muehrcke and Joe Micek of the Americal Division, 132nd Infantry Regiment - Joe is also the Senior V.P. of the Guadalcanal Campaign Veterans organization), has set up a joint venture with the U.S. American Battle Monuments Commission for the construction of a very impressive Memorial on Hill 72, Skyline Drive, Guadalcanal.

The Memorial site gives an excellent view of the major battle areas of WW II; Red Beach, Henderson Field, Bloody Ridge, Tulagi, Iron Bottom Bay, Savo Island, Mount Austen, Lunga Point, and Cape Esperance.

The U.S. Commission of Fine Arts has approved the prototype design which is essentially a 24-foot high square granite column (an obelisk) for the hilltop setting. The Monument is similar to the one on Utah Beach, Normandy, France memorializing the American beach-head established "D-Day."

The base of the Monument will have polished granite directional strips imbedded in the exposed aggregate floor. The strips will be about 3-feet wide, 6-feet long and 3-inches thick and run in the direction of the points of interest. Information about a specific battle will be inscribed on the strip. Granite for the construction is being imported from Italy.

This Memorial will be very impressive as the site selected is outstanding and the view excellent. An all-weather road exists. Under a Joint venture arrangements with the U.S. Battle Monuments Commission, perpetual care and maintenance will ensure the attractiveness of the Memorial.

The Foundation will also construct a series of smaller obelisks on the individual major battle sites plus plaques in the Henderson International Airport Terminal. This is the second phase of the overall American Memorial Project. Following completion of the Memorial on Hill 72, a series of photos will be published in this newsletter. Hopefully construction will be advanced far enough to be part of the 10th Year Anniversary Celebration activities recognizing the Solomon Islands as an independent Nation. Representatives from around the world will gather at Guadalcanal during August 1988; The foundation will have representatives present.

For those of you that may have revisited Guadalcanal, you probably saw the very impressive Military Memorial Park constructed on Mt. Austen by the Japanese in 1982 honoring all nations involved in the Battle for Guadalcanal. We believe our Memorial will be equally, if not more so, impressive due to the outstanding location.
