



In the May-June issue of the newsletter, there was an item about the Bronze Star Medal being authorized for all men who earned a Combat Infantry Badge during WW2, Korea, or Vietnam. Executive order 9419 authorizes the award only for WW2 vets. Korea and Vietnam vets are not eligible for this special award.

ADVA member Joe O'Brien spotted the error and wrote to us with documentation supplied by the Department of the Army. In a letter to Joe by the Military Awards Branch, LTC H.M. Rangel, stated that there were valid reasons for limiting the special award to WW2 vets. At the end of WW2, General Marshall was concerned that many deserving combat veterans had been overlooked for recognition because the Bronze Star had not been established until February 1944 (more than two years after WW2 began). To alleviate this problem, a special provision was established in 1947 so that any soldier who had been cited for "exemplary conduct in ground combat" was eligible to receive a special award of the Bronze Star. The citation could be in the form of a citation in orders, a certificate, or orders awarding the CIB or Combat Medical Badge (since the initial criteria for these badges required "exemplary" conduct). This provision was not extended to veterans of subsequent conflicts because field commanders were fully aware that the Bronze Star was available for award at their discretion during the entire period of hostilities. Therefore, a written recommendation for the award was essential to ensure that all awards were properly justified.

## VETS STILL PURSUING JANE FONDA

From S.J. Nichols in New York, we hear that a coalition of state veterans groups is calling on Congress to investigate whether treason charges should be brought against Hanoi Jane because of her 1972 trip to North Vietnam. If probable cause is found, she is to be tried in US District Court.

The vets group is called the Connecticut Veterans Coalition Forum. Hanoi Jane's spokesman calls them "a tiny desperate minority which will only backfire on all veterans".

Just in case any of you old grunts are in a mood to write to Hanoi Jane and let her know where you stand, her address is printed below. I tried it and was quite surprised when I received a response from her secretary.

To be brief it described how Vanessa, a junior at Brown University, recently returned from her second trip to Nicaragua where she has worked on a building project, hauling wood. She is quoted by the STAR as saying "What I'm doing is different from what my mother was doing in Hanoi. At the time my mother thought she was making a humanitarian gesture. I'm not trying to make a statement. I'm just trying to help build a school and clinic for an individual town."

Poster petitions are coming in regularly but we need more. Send them to your member of Congress or if you have petitions with signatures from more than one Congressional District, send it to the VWMP office to use with Congressional Committees, the Fine Arts Commission, etc. If you need more petitions, contact the VWMP office in Washington.

By a vote of 96 to 1, the Senate passed S. 2042.

The House Bill had 219 co-sponsors when it went to its Sub-Committee hearing on June 21st, but a new bill (HB 4870) was introduced. This bill has the same language as the Senate Bill and will eliminate the need for a Senate-House Compromise Committee and further delays. However, each one of the 219 House members must be contacted to co-sponsor the new bill and we still need the rest of the members of the House to agree to co-sponsor. We have found that many members of Congress are supportive once they have been contacted and the intent of the bill explained to them. In many cases, just one call from a constituent was enough. So please pick up the phone and call. This bill will hopefully come before the full House in September.

FROM: The Women's Advisory Committee of the New Jersey Agent Orange Commission

The purpose of this open letter is to solicit the participation of women who served in Vietnam during the war years in a research study being organized by the New Jersey Agent Orange Commission.

This initial study will focus on problems of reproduction such as spontaneous abortions, still births, infertility, birth defects, and early menopause. We, as the Advisory Committee, along with the staff and researchers associated with the Commission recognize that there are other problems that are not reproductive in nature. This study is therefore a starting point, and other work will be undertaken in the future.

In addition to women who have had reproductive problems, we need women who have had no problems at all as well as women who to the best of their knowledge have had no exposure to Agent Orange.

The primary researchers of the study are Dr. Peter Kahn of Rutgers University, Dr. Michael Gochfeld of the University of Medicine and Dentistry of New Jersey-Robert Wood Johnson Medical School, and Dr. Christoffer Rappé of the University of Umeå in Umeå, Sweden. Dr. Rappé is an expert in dioxin chemistry, and one of the principal features of the study will be the measurement of body dioxin levels of the research participants. The first phase of Commission sponsored research was published in the Journal of the American Medical Association in the issue of March 18, 1988.

TRAGEDY AVERTED BY 196TH 'CHARGERS'  
by Capt. George F. Bennet

LZ HAWK HILL, (196 Inf Bde 10) - Courageous actions and sharp wits were instrumental in averting a tragedy recently by 15 "Chargers" of the 196 Infantry Brigade.

The Reconnaissance Platoon, 1st Battalion, 46th Infantry, had just departed their Night Defense Position (NDP) on a routine search and clear mission when their training was put to the maximum test.

The platoon led by 1st Lieutenant Carl D. Hewitt III of New Johnson, Tenn., had gone only 100 meters when the explosion of a Chicom grenade rang through the air. This combined with the crack of AK-47s alerted the platoon that they were in the heart of an enemy ambush zone. In addition to the flying bullets, enemy whistles were sounded as the VC prepared to assault.

Initially the fire was so strong that when they hit the ground, each man was convinced that he was the only survivor. This immediately was recognized as an error when their instincts and training enabled the platoon to return fire and repulse the attack. Not only did they repel the advance, but they were also credited with five confirmed kills, out of enemy of unknown size. I rebuffing the charge each soldier displayed true valor.

An estimate was made by Sgt. Jack Farmer of Monterey, CA, the platoon sergeant. "I returned fire with my M-16 -- started throwing frags and directing the fight," Farmer said. "I also went to bring up the pig (M-16 machine-gun)."

Once the initiative was regained, S/Sgt. Frank S. Ferguson of Los Angeles, a 3rd tour volunteer, maneuvered his machine-gun into Position. He leveled a devastating curtain of fire upon the enemy, which gained fire superiority for the platoon.

Sgt. Ervin E. Powell of New Washington, OH hasn't been in the field long enough to receive his LIB (Combat Infantryman's Badge) yet his quick thinking and aggressiveness enabled him to save the life of a platoon member.

Powell saw a VC discard his AK-17 and pick up an injured Medic's M-16. Powell immediately shot the VC and proceeded to administer first aid to his wounded comrade.

Reinforcements were airlifted into the area of contact. However, the enemy knew he had met the "Professionals." He rapidly broke contact and evaded. The members of the platoon, all volunteers, were later awarded four Silver Stars, nine Bronze Stars for valor, and two Army Commendation Medals for valor.

## COVER STORY

On August 7, 1942, the United States Marines invaded the island of Guadalcanal--the first offensive ground action of American forces in World War II.

During the bitter six months campaign that followed, every branch of the United States Armed Forces became involved in the struggle to push the Japanese into the sea.

The battle of Guadalcanal was historic because it here that the Japanese Army suffered its first defeat since it began offensive action in China in 1932. During these many years Japan's Army had rolled across China, attacked Pearl Harbor, the Philippines, Indo China, the Malayan Peninsula, Dutch East Indies, New Guinea, New Britain, Northern Solomons, dozens of lesser known islands and had never tasted defeat.

But the Japanese Army was defeated and from here the United States Armed Forces started on that long road that ended in Tokyo.

Shortly after the end of World War II an organization was created by the men and for the men that fought on Guadalcanal, in the sky above Guadalcanal, and on the waters that surround Guadalcanal. This organization is -- GUADALCANAL CAMPAIGN VETERANS -- If you are eligible to belong and you do not, you should. the person to contact is:

On August 7, 1988, forty six years after the invasion, the Guadalcanal Campaign Veterans organization dedicated a Museum in Kalamazoo, Michigan.

The picture on the cover is that of a monument that was erected in front of the Museum.

As you all know, during the time the Marines were landing on Guadalcanal, the Americal was on alert in New Caledonia.

The Navy had a bad time of it following the invasion of Guadalcanal and because of the loss of carriers and the loss of four heavy cruisers in one night, they withdrew taking with them much needed Marines supplies that they had been unable to unload.

The waters around Guadalcanal were not safe waters to take a convoy into and it was not until October that more troops were sent to support the Marines.

On October 13, 1942, the 164 Infantry Regiment landed on Guadalcanal take their place beside the Marines and in so doing were the first United States Army ground unit to take offensive action against the Axis powers in World War II -- that put the Americal Division on the road to Tokyo.

About the same time that the 164 Infantry landed on Guadalcanal, Admiral 'Bull' Halsey took over command of the South Pacific area and then things began to happen.

GUADALCANAL -- 46 YEARS LATER

It was quite a trip! We flew from O'Hare to San Francisco, then to Honolulu, then to Fiji, (Nadi Airport--or Nandi as we knew it) and finally to Henderson Field, Guadalcanal.

The three day stay in and near Suva was neat. They are some beautiful resorts on the beaches. I stayed at the Travelodge, next door to the old Grand Pacific Hotel. (Remember it well from my visit to Suva after leaving the 'Canal in April of 1943). While in Suva I purchased some cultured pearls and black coral necklaces for the ladies of the household.

One evening while in Suva, the tour group were guests of the Returned Services League--similar to our VFW or American Legion. I had an interesting conversation with a former Fijian Scout and an Aussie who served on the 'Canal in 1942-43. Beer and d'oeuvre's were served all during the evening. Melanesian farewell songs closed the festivities.

Arrived at Henderson Airfield on 8/4/88. I was very surprised at the very small terminal. Several plaques, dedicated to the Army Air Corp, were on the wall of the terminal building and just outside of the entrance were several monuments to the Marines. As we bussed to Honiara, we stopped at the old rusting dump containing Amphibious Tanks and then on to 'Invasion Red Beach'. Really nothing there--an old Jap artillery piece--no markers, no monuments, no signs, no directional arrows, --no nothing! I took a long distant look at Savo Island, Iron Bottom Bay and Florida Island.

The next stop was the abandoned Fighter Strip on Koli Point. The cement runways are still intact. After a trip over a very poor road, a stop was made at Edson's Bloody Ridge. Here there is a six foot marker. Not much for a great battle! Bussed over the Lunga, Alligator Creek, Ilu, Tenaru and Matanikau rivers. Then off to Mount Austen to see the impressive 4 story Jap monument and Peace Park. Finally to Hotel Mendana for a much needed rest.

The evening featured dinner at the Laperouse Restaurant, just west of the Mendana. The dinner guests were 'Jock' Stevenson, our architect on Guadalcanal, and Bob Reynolds, head of Valor Tours.

The next day we talked to a group of Aussie GI's who were part of a bomb demolition team. By using detectors and information supplied by the Islanders, the team is locating and destroying old ammo dumps, bombs, grenades, and shells.

Bussed toward Cape Esperance and located a Sherman tank deep in the jungle (named Jezebel). Then to a nearby beach to view the remains of a Jap transport and we next visited Fred Kona's World War II Outdoor Museum and saw all of the debris of war: parts of planes, artillery, machine guns, shells, etc. Viewed the GVC monument alongside the Jap monument--very impressive. Fred Kona then served refreshments under wet palm leaves. This included watermelon, bananas, mangoes, coconuts--fresh from the jungle! Continues next page

Then to Vitale, (place were Japs evacuated 9,000 soldiers on 2/7/43 to 2/8/43) I had a patrol out that same day, just across the bay where the evacuation took place! Following this stop we journeyed to our planned Memorial Site on Hill 72, Skyline Drive. The Matanikau River is on the eastern base of our bluff site, about 3-5 miles inland (south of the ocean).

On Saturday we boarded an old wooden boat and headed across Iron Bottom Bay for Tulagi, Gavutu, and Tananbogo at about 7 mph. Coolers with beer and lunch were aboard and some Scuba divers joined us.

The first stop was made on Tulagi and we visited the beach stormed by the Marines on August 7, 1942 (One of our group had been in that assault). Then on to Gavutu and Tananbogo for a view of the landing area. (one of our group had been in on the invasion of Gavutu).

We had left the Scuba divers at Tulagi to search the bow of the USS New Orleans sunk near Tulagi. On our return trip we stopped to pick up these men. The had brought up a dozen USN flashlights they found in a rotting box under silt and coral. Each of us were given one 'torch'. The flashlights were fairly well preserved. After I clean mine up I may donate it to the GCV Museum.

On Sunday noon I sponsored a luncheon, by previous arrangement, at the Jade Garden Chinese Restaurant. Guests included the US Attache, British High Commissioner, Secretary to the Prime Minister of the S.I., Minister of Lands, our architect, Rev. Dave Bidon, and a radio newscaster. We discussed our proposed Memorial Park and the U. S. Battle Monuments Commission's huge obelisk (our joint venture). After lunch a Memorial Service was held at the site.

Monday, my group left for Australia and I remained on Guadalcanal until Thursday August 11, 1988 to conduct further business in regards to our Memorial Park. During this time I was interviewed by the local radio station and I spent a full day revisiting battle sites including a visit to Sir Jacob Vouza's home, deep in the jungle. Souza and his wife are buried there.

I also toured the hills on Mount Austen and particularly Hill 27, (elevation 1,540 feet), which my Battalion stormed on Dec '42 and Jan '43. I believe I actually found one of my fox holes on Hill 27 which had a lot of coral rock on it, hence, not to over grown with jungle green. The site of the Battle of the Tenaru was visited along with Col. Fox's observation bunker. The final stop of the day was the Seventh Day Adventist Betakama Church/School. Here also is an interesting collection of war relics.

I had an excellent driver/guide with an air conditioned Toyota. Heat and humidity were terrible!

Before leaving for home I was interviewed by Radio New Zealand and had a long meeting with American embassy Attache', Bill Warren.

This is a brief outline of my activities during this most interesting, hot, humid, weird and exciting tour of the World War II battle sites on Guadalcanal. Technically I was representing the U.S. Battle Monuments Commission and the Guadalcanal-Solomon Islands War Memorial Foundation. I was able to accomplish a great deal

and our construction plan will be underway shortly. I met many officials, both in the public and private sector, and it was a very interesting, informative, exciting, and productive visit.

P.S. I took a spoonful of sand/dirt from each battle site and put same in a plastic bag. I plan to mix them all in a special jar, with a proper label, and maybe give the jar to the GCV Museum. (Did you clear this souvenir through the Agriculture Dept. when you left? Ed.

Ed Note; Joe Micek served in G Company, 132 Infantry during the Guadalcanal campaign. He is presently Senior Vice President of the Guadalcanal Campaign Veterans and Treasurer of Guadalcanal-Solomon Islands War Memorial Foundation.

## 164 INFANTRY

Dear Jim;

I just got my copy of the '164 Infantry News and it said that you would like some news from someone from the flame thrower team that assisted the 182 on Hill 260. I was one of the men in that platoon. I was from Anti-Tank Co.

From my Company there was myself, Jack Crawford and a fellow whose last name was Christopher. The rest of the platoon was from different Companies.

We were in training to use flame throwers but on the third day of our "training" we were on our way up to Hill 260. We spent nine days on the Hill taking out one or two flame throwers a day.

On the day I went up we took five flame throwers. We fired the juice from four and set it on fire with number five. What a blaze!

Our platoon consisted of 1 officer and 28 enlisted men. I was second in command of the platoon and when the Platoon Sergeant was wounded I took over. We stayed together for a time after Hill 260 but we were not called into service again.

Of the 28 men in the Platoon, one was killed and twelve were wounded. I received a Purple Heart and a Bronze Star. My wound was not so serious so I guess I was pretty lucky.

THE ALUMINUM MS  
OBSERVATION HILL

0: 700 10 MARCH---- 3rd platoon, 17th Infantry have broken into American perimeter on observation hill followed by 1st company 3rd Bn, 13 Infantry. Penetration made on north point of perimeter. 10 enemy killed, our losses one killed and five wounded. 12th Company continuing to attack.

0: 800 10 MARCH---- Observation Hill now occupied by 1st Company except ridge extending N. W. of observation tree. 2nd Company now deployed east perimeter to torokina River. 3rd Company in reserve at base of hill. No further casualties.

0: 900 10 MARCH---- Estimated platoon of enemy seized south portion of perimeter. Estimated two platoons of enemy reinforced ridge N.W. of observation tree. Heavy enemy casualties. 6th perimeter attacked north. Enemy platoon on south but were repulsed by 2nd Company and have withdrawn to original positions on south perimeter. Our losses four killed, three wounded.

1: 1000 10 MARCH---- Enemy platoon on south perimeter receiving reinforcements. Enemy dead identified as belonging to 182 Infantry, American Division.

1: 1200 10 MARCH---- Enemy attack from south perimeter crushed by 1st Company, many enemy casualties. Our own losses one killed, one wounded.

1: 1300 10 MARCH---- Additional enemy attacks from perimeter and NW ridge defeated. Many enemy casualties and many wounded.

1: 1400 10 MARCH---- Enemy attack between Torokina River and perimeter forced back by 2nd Company. Three dead. Our losses two wounded.

1: 1500 10 MARCH---- All quiet on hill. 1st Company improving positions.

1: 1600 10 MARCH---- Heavy enemy mortar bombardment. Our losses five killed, 6 wounded.

1: 1700 10 MARCH---- Heavy enemy attack from south perimeter in progress.

1: 1800 10 MARCH---- Enemy forced back to original positions on south perimeter. Our losses 4 killed, 2 missing, 6 wounded. Enemy casualties heavy.

1: 1900 10 MARCH---- 2nd Company attacking south perimeter from east. Heavy fighting in progress.

1: 2000 10 MARCH---- 2nd Company has returned to original position. Enemy too well fortified to be attacked up hill from east. Enemy employed grenades in clusters. Our losses 7 killed, 11 wounded. Enemy casualties estimated as heavy.

1: 2100 10 MARCH---- All quiet on hill. 3rd Company moving into perimeter to prepare for attack on south perimeter.

1: 2400 10 MARCH---- Plans completed for 3rd Company to attack at 0600 toward south perimeter. Nuisance fire from NW Ridge toward south perimeter with two infiltrating attacks repulsed.

0700 11 MARCH---- enemy preparing to attack.

0800 11 MARCH---- Enemy team eliminated. Captured new weapon and are sending it back to HQ. 3rd Company attack now set for 1000. Enemy casualties 1 killed and 1 wounded.

1000 11 MARCH---- 3rd Company attacking -- good progress being made.

1100 11 MARCH---- 3rd company back in original position. 7 killed, 11 wounded. 1st Company will attack on left. 3rd Company on right 1300 hours.

1400 11 MARCH---- Enemy cleared from south perimeter. 17 killed, 15 wounded. Evidence shows at least one enemy company wiped out.

The report ends here. It would be interesting to read the rest of it but apparently it was lost in the battle.

Ed Note: Are any readers able to place themselves in this action? It does tie in with American reports

Lt Hammitt has passed away but he was a career man and conducted a great deal of research into the battles he was involved in and wrote several papers while attending Command Schools. He turned much of his writing over to Lew Turner.
