REVEREND JOHN S. FRANKLIN

On February 23, 1991 the Americal Division Veterans Association lost a true and devoted friend. Reverend Franklin had served as the National Protestant Chaplain since 1965. He was always loyal to the ADVA and was one of its staunchest supporters.

Reverend Franklin was born in Hamburg, Iowa on September 29, 1901 and was ordained on June 9, 1922. He served pastorates in Iowa and Missouri before coming to Massachusetts to serve churches in Medford and Newton.

In the 1940's Reverend Franklin joined the 110th Cavalry, Massachusetts National Guard, as an enlisted man. When the Yankee Division was inducted into Federal service on January 16, 1941, the Reverend was commissioned a Chaplain in the 101st Infantry Regiment. On November 11, 1941, he became a Chaplain to the 182nd Infantry. He remained with this unit through the Guadalcanal campaign. During the Americal stay on Fiji he was transferred to the 164th Infantry and served this unit on Bougainville.

Upon his return to the United States he served at the Chaplain School at Harvard University. He was then assigned to the 213th Field Artillery Group, Little Rock Arkansas and closed his war time service at Fort Sill, Oklahoma, as School Chaplain.

Following his return to civilian life the Reverend answered a call to a church in New York and during the next twenty years served parishes in Brooklyn and the Bronx.

Upon entering semi-retirement in 1965 he returned to Massachusetts and living in Wareham, he served churches in Mashpee, Bourne, and Plymouth. He also served as a summer pastor to a church in Sagamore.

In June of 1972, while serving the church in Bourne, Reverend Franklin was honored with a celebration denoting his fifty years in the ministry. The Baptist Convention, meeting that summer in Hyannis, also honored the Reverend for his fifty years of faithful service. Americal members were invited to attend both of these ceremonies and many did.

Reverend Franklin retired after seventy years in the ministry. Because of failing health he has been in the Masonic Home in Charlton, Massachusetts, for the past several years. He still managed to attend Americal functions until a few years ago and he remembered well the soldiers that he served with during World War II.

Reverend Franklin is survived by his wife, Frances, one son, Horace B. Franklin of Georgia, one daughter, Elisabeth Franklin Willard of New York, eight grandchildren, several great-grandchildren and two nephews.

Three daughters from a previous marriage also survive.

Chaplain John S. Franklin was buried with full military honors in the Massachusetts National Cemetery, Bourne, Massachusetts.

TELL IT LIKE IT WAS

Continued from the last issue of the newsletter:

Before it got totally dark we started wrapping and snapping smaller trees with det cord only then it was too dark again and the rain started. As I started back pass the fire and wounded to spend my third night in the mud and thinking about them very much. I again silently said to them "Guys, I'm sorry I failed you all again, I'm so very much sorry!" At nights in the rain I started pulling my rain parka much farther down over my head to act more and more like an Ostrich and bury my head in the mud cause of all the silent promises made each morning to all the wounded soldiers, and several unknown Mothers whose son was still on the mountain top yet. And each night walk past and silently say I'm sorry I failed you again. It never seemed like the saying would be changed to "we failed you" cause you knew your friends done the best job always it was like I didn't do my job right and if anyone was to be blamed it was me not my friends who should bear the blame. I knew that Fields, Gillespie, and Downey thought much the way I did since we'd been together since AIT and each of us knew the other was thinking I failed but somehow it made us want to live up to the expectations of the

others so we would all work that much harder on a demo mission. The next morning something was different on top of the mountain. The NVA KIA nearly buried by the leaves was missing and we found where he'd been dragged off the trail and down the side of the mountain and never thought much more about it. Without demo we started dragging brush farther down the mountain and hoped that we'd soon get more to finish the job. We wondered about the pin hole opening to the sky we had and didn't know if we could be resupplied with demo, so we kept busy doing what we could with det cord and dragging brush. Late in the afternoon we got a big enough opening that finally we could get demo lowered to us, but it would be too late to return with anyone's rucksack so we'd all spend another night in the rain with little protection. At the end of each day with the clearing just a bit bigger, and the return of the rain again we didn't get out packs or rucksacks, nor get the wounded or KIA's out! Soon each day and night in the rain was a repeat of the first night, the only difference was the clearing was just a little bit bigger but not big enough yet.

Our fourth night I'd doze a while in one pile of mud till it was too wet then get up move and try to find a less wet portion of ground to lay back on and doze a little longer. Most of the time at least three or four of us were always awake and sitting there in the dark would all be thinking why can't tomorrow we give the wounded what they need, a med-evac off this mountain top. The answer was though the clearing was bigger a chopper still couldn't land because there was a tree always too close. If not on the mountain top then down the side of the mountain, one too big or too close to allow for a safe landing.

On the fifth day we were all dropped, our packs and rucks from treetop level and as they hit the ground would bounce and start down hill. Many pack frames were broken. We finally had our gear again but it didn't mean much as what we wanted was to medevac the wounded and KIA's. The next day by some miracle we were able to evac the casualties by making a human ladder to a hovering chopper. At last I saw the soldier I looked at each morning and night, finally leaving the mountain. Our demo mission would continue on that LZ for another eight

days of blasting and dragging brush. We still slept in the mud or sat in the dark listening to the rain. Only we'd gotten the wounded and KIA's off, finally! The second greatest moment for us was when a Chinook touched it's rear wheels down on the mountain top while remaining suspended over the side slope. We watched more infantry unload and a Huey brought in a Psy-Ops Team. Our demo mission was over but how were we going to get off the mountain? We heard the unmistakable thump of rotors somewhere high overhead and Downey hurried to make radio contact, telling them we'd pop smoke. They spotted the smoke and came down for us. They weren't going to LZ Baldy but would take us to another LZ which was fine with us. In this process of "hitch hiking" we were on and off numerous Hueys that day, stopping at LZ's Center, West, Ryder, Polar Bear, finally going to Baldy at about sundown. When we landed on the pad at LZ Baldy, we could see the company area far below. Getting there seemed to be the problem. Gary slung his rifle and began to walk downhill with us doing likewise. A Marine engineer driving a five ton truck stopped to pick us up. We were all nearly too tired to climb into the truck but managed somehow. When the Marine let us off at the company area, we spotted the men playing football. We felt as if we didn't belong here so again slung our weapons and moved single file into the company. The men playing football stopped to stare and no doubt wondered who the men with mud covered fatigues and rucks were. Then I heard someone say "those are 1st platoon's demo men! They were sent out somewhere, sometime back on a demo mission." As we headed to our hooch there stood our CO and XO along with our Terry-Thomas look alike Platoon Leader. We heard him say "Ah, my duds are finally back!" Without stopping, we turned to look at him at the same moment. We knew we weren't duds but from him those were cutting remarks! The misery, pain, a sense of failure was still in our eyes. Our CO saw our eyes and sensed the danger. He told the Platoon Leader to get lost for the night. At the hooch we heard guys inside laughing and talking. As we entered the guys fell silent and stared at the mud covered soldiers as if they didn't know us. We dropped our weapons on the cots, pulled off our muddy equipment and sat down, not seeing the other men. We all looked at each other not saying a word. Now it seemed strange not to be sleeping in the jungle rain and worrying about our wounded. We sensed that we didn't belong here back in our hooch with members of our platoon that we had forgotten all about. It was as if we still belonged to the infantry. That was our unit. We wondered what we were to do? We didn't know and yet we couldn't stay here cause we just didn't seem to belong. Then Gary came to the hooch to tell us the CO had ordered the cook to open the mess hall and fix us something to eat. So again, we followed Gary and as we were leaving the hooch we heard the guys start talking and listening to the radio. We thought somehow maybe we'd belong again. But it was going to take a lot of time as we knew our unit was still somewhere in that jungle.

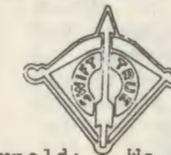

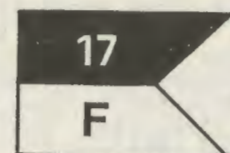

GREETINGS TO THE A.D.V.A.

I was certainly proud to see your ad in the Vietnam Magazine. I have always scanned pages looking for the old Southern Cross with someone's name attached that I served with, but now maybe I'll find someone. I am really excited about being a member of the A.D.V.A. and so is my wife. I am proud of you and what you are doing.

I have enclosed several things I've written over the years. If you desire to use any of them feel free. I simply want to help my brothers.

I have been a minister for over 16 years. I have enclosed a pamphlet which explains what happened to my life after Vietnam. I pray you receive a blessing from it. Pass it on, and should you want more of them please ask. I would be more than honored to speak for the A.D.V.A. at any of the rallies or conventions. Although I do preach the gospel of Jesus Christ, I have also been a spokesperson for the Missing in Action and the Prisoners of War. I have lectured in several colleges concerning Vietnam and I feel it is something I have been blessed of God to be able to do. I am at your service.

I recall the first time I ever witnessed the constellation - The Southern Cross. I have enclosed an account of that night for you. I am looking forward to hearing from you in the future. God bless all of you.

I was with Alpha Company, 2/1, 196 LIB, Americal Division, Central Highlands. I was wounded on September 9, 1969 just outside the city of Tam KY, our losses were heavy. Our A.O. was in jungle and roads in and around LZ Baldy, Hawk Hill, LZ East, LZ West, and LZ Ross. We stood down at Baldy and Chu Lai.

THE SOUTHERN CROSS

The constellation, The Southern Cross, constitutes the star pattern within the Americal Division shield. Mythology, whether true or not, says that the four stars were once a huge meteor which exploded within the heavens when Jesus Christ was crucified two thousand years ago. The Southern Cross cannot be seen from our (the North American) hemisphere. At certain times times of the seasons it is said to be visible from the southern most parts of Florida.

When Stills and Cross wrote their song, The Southern Cross, several years ago (1986 or 87) I felt as if they had witnessed my life while I was in Southeast Asia. One line of the song says, "When you've seen the Southern Cross for the first time, you'll understand just why you came this way..."

One night during June or July, 1969, the second platoon was assigned night ambush several clicks outside the wire just off the road outside LZ Baldy. One of my best friends was a Cherokee Indian. As we lay there that night beneath a heaven which had no man-made electricity to diminish the nature brightness of the stars, we talked of home, and of our families. (at this time I won't address the events that happened) Cherokee asked me if I had ever seen the

Southern Cross. At that time all I had seen was a huge banner over the entrance to the military base at Chu Lai which stated, "Under The Southern Cross." In response to his question, "No," I returned. "Look, there it is." Cherokee replied, in somewhat of an excited tone.

As I turned heavenward and beheld the glorious cross hanging in the heavens our conversation became one-sided. It seems that I momentarily (at least within my thinking) left our present location. As I looked upon this beautiful constellation Christ appeared on it. I was totally shocked. What stood out the most was the agony He appeared to be in. The weight of His body pulling on the huge spikes through each hand was causing His ribs to seemingly push through His skin. The crown of thorns was pressed into His head, which was slumped onto His chest.

There was no drugs or alcohol involved. I was a good soldier and I did not do such things in Nam. At the time I did drink, but only at the LZs or base camps. It was real. Just over two months later I was blown away by an R.P.G. and two Medics left me for dead, but God did not. He brought me back to life.

REPUBLIC OF VIETNAM GALLANTRY CROSS

This cross was established on August 15, 1950 by the Republic of Vietnam, as an award for outstanding bravery by officers and enlisted men who distinguished themselves conspicuously by gallantry in action at the risk of life. It corresponds to the French Croix de Guerre, (which design it resembles).

The bronze cross has flared decorative edges and two crossed swords, points up, between the arms of the cross and superimposed on a decorative wreath-like design, (which is really two "dragon-like" figures). On the obverse in the center is a raised disk with a sprig of laurel at the bottom and a map of Vietnam in the center, which contains the inscription in Vietnamese, "In Remembrance of Work Well Done". The badge is suspended from an ornamental bronze plaque which is attached to the ribbon. The reverse of the cross is blank.

The ribbon is red with a wide center stripe of gold, which is divided by sixteen very thin stripes of red.

11 ARTILLERY MIKE GOTTSCHALK 11 ARTILLERY

Armed with a pen and memories of his days at war in Vietnam, Mike Gottschalk is now recording his experiences for all to see.

Raised in Almont, MI he graduated from Almont High School in 1965, joined the Army in 1969. That same year he was sent to Vietnam for a one year hitch.

Mike served in the 11th Artillery and did his time fighting in the hills of Southeast Asia where the only way in or out was by helicopter.

Since childhood Mike had wanted to make his living drawing illustrations with pen and ink. Between graduation from high school and joining the Army he attended three years of art school at the Center for Creative Art in Detroit.

Now, twenty years later, Mr. Gottschalk works as an illustrator for Modern Engineering at the Great Lakes Tech Center in Flint. Mike is a technical illustrator and designs automobile manuals.

Off hours, he's capturing memories of the Vietnam War on canvas.

In a joint effort with area Vietnam veterans, Gottschalk is distributing limited editions of his "Memories of Nam" poster.

It took him nearly eight months to put together the collage of memories of the Vietnam he knew in 1969 and 1970. The result of his work is 21 men portrayed in ink drawings.

The sketches reproduced on the 24 x 36 inch poster are drawn from photo references taken mainly from "The Vietnam Experience" series of Time-Life books on the Southeast Asian war. (With the publishers permission)

Gottschalk and an ex-Marine friend financed a run of 250 posters. At first offered to local Vietnam veterans of America chapters, they are now on sale to the public.

"I can relate to this subject easily," says Mike. If I am missing something in the photograph, I can remember what it looked like".

"I started this basically for the local chapter of the Vietnam Veterans of America. They wanted a few drawings to disperse about the monthly Newsletter," he says. Then some of the vets suggested I make some illustrations showing various phases of the war. And so I did.

A portion of selling price of each poster is given back to Chapter 287, Vietnam Veterans.

He said he was urged on by friends "who were seeing a lot of mediocre Vietnam art produced."

Gottschalk began expressing his artistic talents at the age of 3, when he carved a then-popular Howdy Doody and Princess SummerFallWinterSpring into his bedpost.

By the fourth grade, his talents were such that a drawing of his father's milk truck was exhibited at a Flint museum for a year.

While Vietnam art and military art in general hold Gottschalk's main interest, his dog portraits have been a popular mainstay. "I've sold more dog por-

traits than anything else," he said. The art community seems to go for non-objective art in general

Still the Vietnam War captures much of his painting time.

Mike is working on a painting of Bob Givens, a Vietnam veteran who died three weeks after visiting the Vietnam Veterans Memorial in Washington, DC.

Drawn from slides taken by Amy Powers, the painting shows a wheelchair-bound Givens at the Wall in an emotional side hug with another veteran.

"Women in Nam" is another project that occupies his thoughts. The work, also done in poster form, is a composite of 14 drawings for the Washington-based Vietnam Woman's Memorial Project.

This poster will show women in various services, the Red Cross and even the USO. Mike says, "I even have Martha Raye's picture on it. She was a great supporter of the war effort."

One of Mike Gottschalk's posters will be delivered to Washington, DC. He is hopeful that one will reach the White House.

In the closing days of the 1990 General Court, the Massachusetts law-makers passed legislation, that was signed by the Governor, clearing the way to build an official state memorial to Massachusetts citizens who lost their lives in the Vietnam War. LETTERS FROM THE OLD GUARD

9th STATION HOSPITAL 9th STATION HOSPITAL
DORIS E. (WHITMAN) LUCAS WORLD WAR II

My version of duty with the 9th Station Hospital, Task Force 6814-A, later known as the Americal Division. The name was given to a mongrel outfit, "Americans in New Caledonia"

The winds of war were blowing all around with the draft taking our boys from mothers, wives, and dear ones. Doctors and nurses were recruited to care for our soldiers.

October 23, 1940, my orders read: Army Nurse Corps, Camp Shelby, Mississippi. From the day I was met at the train, I was known as "Maine Yankee".

Ours quarters were wooden barracks with small metal beds and orange crates for bedside tables. As no dietitians were present, another nurse and I ran the mess.

Christmas Day came around and no one knowing each other, we needed a get-acquainted something. We signed the order slip for eggs and milk from our Mess and ordered brandy (via potatoes). Before the evening ended, we learned we represented thirty eight States--and all of us wondering what the future held in store.

Troops arrived by the thousands. Some outfits drilled with brooms as guns for our country was not prepared for this emergency. Our time was spent preparing the 33-bed wards.

My next assignment was the N.P. Section. (This came about because the hospital where I trained in Exeter, NH, required three months at the New Hampshire State Hospital at Concord). There were two wards for patients and one for prisoners-boys will be boys! This ward was like the other wards except the doors were kept locked and all the glass had wire in it. We had small rooms for the most-disturbed patients - men that could not cope with military life and were to be sectioned out.

September came with things happening to enhance our thoughts of war. Only half of the camp was allowed off at one time. Officers that we saw one day were missing the next.

December 7, 1941, a group of nurses headed for New Orleans (it was our favorite place for R & R). As one drove down Canal Street, paperboys were holding their papers high and screaming "War". We headed for the cocktail lounge at the Hotel Jung. Through loud speakers came, - "All military personnel to return to their post immediately!"

Orders came, for those who volunteered, to leave for points unknown. This was to happen before Christmas of 1941.

Due to the failure of our ships being ready, we did not leave until early January for New York, Port of Embarkation. I later learned that our medical units were to be responsible for the care of the sick and wounded of the approximately 17,000 troops that were in the convoy.

These units were:

- 9th Station Hospital)
- 52nd Evacuation Hospital) USNT Barry
- 4th General Hospital)
- 101st Medical Regiment) USNT Santa Elena
- 109th Station Hospital) USNT Argentina
- T.P. Surgeons Office) Flag Ship

Nurses were assigned to every ship.

We were never issued uniforms except white (1918 style) and Army Caps. When orders came, they stated one could take a couple of civilian outfits. We had to take coats, mine - a racoon - for I had come to Camp Shelby from Maine in cold January. Everything else, all we held dear, was to be sent to whatever destination we requested. The uniforms would be aboard. The would come from Philadelphia Army Depot. NEVER ARRIVED!

The first night on board, still in the harbor, we had a meeting of all hands. The journey would be at least 30 days. Thoughts of Europe now faded and we seemed to be heading for the Pacific.

Feeling the vibration of the ship one night, we knew we were sailing. It was the next dawn that the alert sounded and we were ordered on deck immediately. No time to dress, we grabbed our lifesavers ("May-West" - the name finally given for good) and coats, and with long silk nighties and mules (fancy slippers with heels and fur), we rushed to the decks.

Immediately the order was received that one would remain dressed at all time. All portholes were to be closed at night and nothing thrown overboard.

We zig-zagged along the Atlantic. First you would see a ship and then you would be alone in the submarine-infested waters.

It took nine days to reach the Panama Canal and a day to go through the locks. We transferred some patients, too ill to complete the voyage, to a hospital in Panama. That night, we spent in Colon where a few officers got off to determine our destination. It was learned that we were headed for Perth, Australia.

At night we played cards, by "she sitting out and he sitting in, that protected the nurses from sin". Two meals a day and our lunch was various inoculations. We were allowed on deck at certain times and the enlisted men, who were billeted in the holds of the ship, were brought up for sunshine.

The next stop was the island of Bora Bora for refueling. The natives and not-so natives came to greet us in outriggers. G.I. caps were traded for bananas via portholes. One beautiful, sunny a.m., a huge ship was sighted. We thought the Japs were about to attack but it was an Australian ship.

We landed in Melbourne, Australia in March to unload the 4th General Hospital. What a surprise the Red Cross got when they saw poorly-dressed, stinky

outfits, with fur coats, getting off of the ship. No matter what, they were glad to see Americans because their forces had been sent elsewhere in the Empire to fight. We were taken to a home for wounded Australians. We were not permitted to leave the home except to get fresh clothes to wear.

I faithfully read the Americal Newsletter but Claire Egan is the only one that I ever read about. Hope you enjoy the story and if there are anymore Caledonian Nurses out there I would love to hear from you.

It was nice to receive your note along with my Life Membership card.

I was surprises to see the pictures that I had sent in for the NEWSLETTER. I said to my wife, "these are the same pictures that I have--and then I read the article". I was with the 22nd Ordinance Co. and sailed with Task Force 6814 on 23-Jan-42. After a stop in Melbourne, Australia we went to New Caledonia and became charter members of the Americal Division.

I made the trip to Guadalcanal on the Barnett and we arrived just as the sea battle of Savo Island ended. The other ship in our convoy, the Alsheba, caught a fish and burned for the next two weeks while troops unloaded much needed ammo.

The Division pulled out in March and the 721st Ordinance Co. was formed. It was made from parts of the 22nd, 51st, and 82nd Ordinance Co.s. I remained with the 721 through Cebu and returned to the States on August 22, 1945--forty three months after leaving Brooklyn Navy Yard!

Bob Griffiths and Fuss Hill, my two closest Army buddies both passed away in the past three years. Bob lived in Scottsdale, AZ and we exchanged visits on several occasions. Russ lived on Maui. We spent a week with him and Dottie in 1969 and they visited us in 1984.

THE PHILIPPINE LIBERATION MEDAL



This medal was authorized by the Philippine Commonwealth Army Headquarters in 1944. It is awarded to personnel of the United States Armed Forces for service in the liberation of the Philippines from October 17, 1944 to September 3, 1945.

It is believed that this award and the two following were designed by the firm of EL ORO in Manila. This firm also supplies all of the decorations and awards of the Government. On the obverse it has a Philippine sword, point up superimposed on a native shield, this has three gold stars on white enamel at the top, below this a gold band with the word "Liberty" in raised letters, beneath this are three vertical stripes of red, white and blue enamel, with the sword on the center white stripe, the shield is superimposed on a pair of arched wings (in gold) that flow down both sides of the shield. The reverse of the medal has the inscription, "For the Liberation Of The Philippines" in four separate lines.

The ribbon is a deep red overall with a narrow stripe of blue and white at the center of the ribbon.

SOLOMON ISLAND STRUCK BY EARTHQUAKE

A major earthquake struck the Solomon Islands on February 10, 1991 according to the U.S. Geological Survey.

The quake measured 6.9 on the Richter Scale, the survey said. There was no immediate reports of injury or damage.

The quake was centered on the island of Guadalcanal, about 55 miles west of the capital of Honiara, said Pat Jorgenson, a spokeswoman for the survey team.

The Solomons are a chain of islands stretching across 900 miles of the southwestern Pacific Ocean east of New Guinea. They have a population of 315,000.

The quake generated no tsunami, said an official of the Pacific Tsunami Warning Center in Honolulu.

Under the provisions of AR 672-5-1, Paragraph 96, to be eligible for the award the individual must be an Infantry Officer, Warrant Officer, or Enlisted Man with an 11 digit MOS and perform duty as a member of an Infantry Brigade size or smaller unit, during any period such unit was engaged in ground combat.

The Combat Infantry's Badge was first authorized for service in Vietnam in 1 Mar 61.

The award was established to enhance the prestige of the Infantryman assigned to a combat infantry unit whose daily duty is to meet and destroy the enemy.

The Combat Infantryman's Badge was established to give recognition to the special job you are doing. WEAR IT WITH PRIDE.

Enclosed is a reply from one of my Congressmen in reply to the letter I wrote protesting the demise of the 182 Infantry. Can't say as it clears up anything--

Thanks for your recent letter about the National Guard and specifically the 182 Infantry. The administration did propose significant cuts in the National Guard end strength as a part of the reductions the Pentagon plans over the next few years.

During deliberations of the Defense budget this year it became clear that the Defense Department had not thought through their plan very well. They had simply said that if we are going to cut active forces 10% then we should cut the Guard and Reserves 10% too. I believe that is the proposal you referred to in your note. The Congress was not convinced by the department argument. They had failed to tie their end strength requirements to the new threat or to consider moving some active forces into the Guard where the cost is reduced and the forces can be used if they are needed. Because of these problems the congress directed the department not to cut the Guard this year. They were directed to review their overall requirement in light of the new threat and propose any changes in their next budget request.

It is possible that the Guard and Reserve may lose some units over the next few years but it is too soon to make a prediction as to how many or which ones. Thanks again for writing about this important issue and I hope this information will be useful.
