21. NARRATIVE DESCRIPTION (Describe in detail what the indiv did that warrants the special recognition afforded by a decoration. Use plain bond paper for continuation sheet if necessary)

SFC Paul L. Moulton, RA 11 163 069, distinguished himself by heroic and meritorious achievement while serving as photographer on six aerial surveillance missions in and south of the demilitarized zone at the 17th parallel. The mission objective was to photograph North Vietnam military activity within the demilitarized zone as evidence of North Vietnam violation of the Geneva Accords of 1954. SFC Moulton accompanied the delivery of a new high magnification camera system to the Army Concept Team in Vietnam from CONUS for the purpose of familiarizing personnel in ACTIV with the operation of the camera system. SFC Moulton arrived in country 23 July 1966, assembled the camera equipment 24 July 1966 and accompanied it on a test flight in the Saigon area. The aforementioned special intelligence mission originated at this time and since SFC Moulton was the sole photographer in Vietnam with sufficient knowledge concerning the operation of the camera system he was assigned as photographer for the mission. SFC Moulton performed his assigned task admirably. Repetative flights were made at dangerously low altitudes and airspeeds over extremely unfavorable enemy offensive positions. Despite the heavy artillery, mortar and anti-aircraft fires being conducted in the area he diligently concentrated on photographing the target areas pointed out to him. His courage combined with his professional skills and dedication to the mission were resultant in obtaining many photographs of North Vietnam military activity in the demilitarized zone. SFC Moulton's actions were in keeping with the highest traditions of the military service and reflect great credit upon himself and the United States Army.
