KNOW ALL MEN BY THESE PRESENTS:

NOW, THEREFORE, the condition of the above obligation is such, that if I shall truly and faithfully perform my duties, including (but not by way of limitation) certifying vouchers for payment, accounting for, paying over, and delivering up of all fees, moneys, goods, effects, books, records, papers, and other property that shall come to my hands or to the hands of any other person to my use as an officer of the Foreign Service under any law now or hereafter enacted and shall truly and faithfully perform all other duties now or hereafter lawfully imposed upon me as such officer, then the above obligation shall be void, otherwise it shall remain in full force and effect.

IT IS AGREED that this bond shall be construed to be conditioned for the true and faithful performance of all official duties of whatever character now or hereafter lawfully imposed upon me or by me assumed incident to my employment as an officer or employee of the Foreign Service of the United States.

IT IS FURTHER AGREED that, as FSR-Officer this bond shall be construed to be conditioned for the true and faithful performance of all my acts incident to my office.

IT IS FURTHER AGREED that, in the event that the United States brings action upon this bond and I live in a foreign country, the service upon me of summons or other process may be made by serving the Secretary of the Treasury with such summons or other process with like effect as if served upon me in person; and I do hereby appoint the Secretary of the Treasury my attorney and agent to receive and accept service on my behalf of all lawful process in connection with such action brought upon this bond.

This bond is given pursuant to Section 1011 of the Foreign Service Act of 1946 (Public Law 724 - 79th Congress).
