SWORN STATEMENT

I, JACK P BYERS

WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH

On 8 Oct 69, Mr Fredrick Joseph WIDMER, was interviewed at his home at 221 Crescent Drive, Lower Purrell, Pa 15068. WIDMER stated that he was present at My Lai (4) on 1st Mar 68, as a member of C Company, 1st Bn, 20th Inf, 11th Reg as a part of security for Headquarters Section. WIDMER normally had the job as RTO however on this mission MURRAY was being broken in as a new RTO by PAUL. WIDMER related that during a briefing on 15 Mar 68, by CPT MEDINA the troops were told that during the mission, Task Force BARKER, everyone was VC or VC sympathizers and supporters and everything was to be killed meaning people and animals. MEDINA reminded the troops that their company had lost persons before in the area they would be going into. There was one other briefing held about the operation the night they returned to base camp. There was no company formation but MEDINA held a "gathering" and informed those present that someone had made a complaint about civilians being shot. MEDINA stated that he was responsible that the troops were following his orders by burning the building and killing everything MEDINA told those present not to discuss the incident with anyone. WIDMER believed the incident had been reported by a gunship pilot.

WIDMER claimed he went into My Lai (4) with the last lift and was also behind all others while going through the village. He estimated the time spent in and around My Lai (4) to be between 0900-1200 hrs. WIDMER stated he saw an "easy 50" dead civilians lying dead in and around My Lai (4) and that no one was alive when the unit left the village.

WIDMER claimed he was within sight of MEDINA most of the time and denied seeing MEDINA shoot anyone. WIDMER was about 3 steps past CARTER when CARTER was shot in the foot therefore could not state if it was an accident. Most of the time around My Lai (4) WIDMER was with WEST the squad or team leader, SMITH, and SMITH and he could not remember the others in the team and WIDMER was armed with an M-79.

When asked MEDINA's reaction to seeing the village burned and people shot WIDMER stated that MEDINA had nothing to say as it was his orders. WIDMER did recall that MEDINA called the platoon leaders and was mad and told them to stop killing the people however WIDMER could not remember if this occurred before or after BARKER visited MEDINA.

According to WIDMER no enemy soldiers were captured at My Lai (4) however a weapon was captured some distance from the edge of the village, ~~while~~ ~~was~~ ~~being~~ ~~burned~~ by DELPOME, GRIMES (team Leader), and 4 or 5 others. WIDMER made reference to a picture on page 32 of THE AMERICAL, May edition and claimed that DELPOME was the person closest to the camera when the photograph was taken.

WIDMER opined that although the company went into the village with instructions to kill everything and everybody the situation got out of hand.

Later that day WIDMER claimed he saw some National Police and Military Intelligence personnel interrogate some prisoners (at least 2) One of the prisoners was an old man and dressed in white. The interrogations took place ~~near~~ the CP. WIDMER denied seeing the prisoners shot but a short time later he saw two persons dead in a ditch and on

was the old man dressed in white.

At the beginning of the interview WIDMER stated that he had already talked to CCL WILSON and did not think he had anything else to add and would make no statement under oath.

WIDMER stated he did not see POYCE, CONTI, OLSON, DCRSI kill anyone and when asked about MEDLO he said he could not give a definite answer. When asked if he saw anyone actually shoot civilians he replied "No Statement".

WIDMER was then advised of his rights and told of what he was suspected (murder). WIDMER then signed part one and II of Waiver Certificate and stated he did not want to make a statement or answer any more questions.

WIDMER will not testify if called.
