

It should be noted that TUAN has no education and appears much younger than eight years both in appearance and actions. If TUAN is now eight he would have either been 6 or 7 on the day in question. TUAN stated substantially as follows: On the day of the killing in his village he was out in the field. He heard much shooting from his village but saw no US soldiers. He ran and hid in the rice paddies. He does not know how long he stayed there but later went to the village. At a trail leading into the village he saw many dead people but does not know how many. He saw no other dead persons at any other location. He states his family's home was burned. They owned two pigs and four cows which were killed. He saw the dead cows but did not see the pigs. He was told they had been killed. TUAN could not remember if US soldiers, had been to the village and could furnish nothing further concerning the day in question. A photograph of TUAN was obtained.
