SWORN STATEMENT

1. ARVIL JACKSON KIRK JR., WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH.

INVESTIGATOR'S STATEMENT

On 27 December 1969, between 1110 - 1215 hours and 1320-1500 hours, TU was interviewed by me in the presence of 1LT John C. WOOD, Hq MACV, APO SF 96222. TU's personal data is as follows:

TU stated substantially as follows: About 0800 hours, on a morning in Mar 68, he was working in the rice paddies about one kilometer from his village Tu Cung, when he saw helicopters landing near the village. He does not know how many helicopters there were and saw no soldiers. He then ran to Son Hoi Village and stayed until that afternoon. While in Son Hoi he heard some shooting but not too loud. When he returned to his village he came upon the main trail into the village. He saw many bodies on the trail and off the sides of the trail but could not guess or estimate how many. He found the bodies of four relatives. Tran Thi HIEN, 50, female, adult; Pham Thi TUAN, 40, female, sister-in-law; Nguyen Thi HUYNH, 15, female, niece and Do Thi NIANH, 10, female, niece. His son Nguyen Van CHUONG, 10, was in the village but was not hurt and is now at an unknown address on Ky Dong Street, Saigon. He heard that Pham DAT, 42, male was wounded in the foot, Tran Thi HOA, 16, female was wounded in the stomach, a person known only as DOC, 70, male was wounded in the stomach and Do BA, 16, was wounded in the fingers. All are presently in Son My with the exception of HOA, who is at an unknown address in Saigon. He estimates that there were 370 people killed and 100 people wounded, some of which lived and some of which died later. The relatives buried their own people. He stated that his house was burned and his animals and birds consisting of five cows, three pigs, ten chickens and one dog were all shot and killed. He saw the dead animals but did not see them shot by soldiers. He was told that soldiers shot them. He stated that there were four families who lived near him and their homes were destroyed. The families are: 1. Do CAM, 45, male; Nguyen Thi THI, 42, female; Do BA, 16, male and several children. He only knows the name of Do Thi LANG, 13, female. All are alive and now live in Son My. 2. Nguyen Thi HOA, 60, male; a person known only as LAU, 55, female; Nguyen Thi HOA, 30, male and Nguyen DINH, 14, male. HOA and LAU were killed, DINH is in Son My and he does not know the whereabouts of HOA, 3. Truong CHAU, 70, male; Truong DE, 36, male and three persons known only as LIEU, 55, female; BONG, 30, female (DE's wife) and DUC, 6, male. CHAU, BONG and DUC are at unknown addresses in Saigon and DE and LIEU were killed. 4. Nguyen Thi EM, female, 35, and two children, females, names unknown. EM and children are now in Son My.


TU could not furnish the names of any other persons near him or in the village dead or alive. TU did identify a photograph depicting an old man with two children as Truong CHAU, age unknown. They are at an unknown address in Saigon and he does not know the names of the children. He identified a photograph (last Black & White Photograph in the series) depicting several persons in a small group, some squatting and some standing. He identified the third man from the left, squatting with a white cloth on his head as LAN, from Binh Dong Village. He further stated that LAN was killed later but not as a result of the operation in Mar 68. TU stated that he heard from an unknown person that Troung THO, 70, male was killed in a well near the main trail leading into the village. As far as could be determined TU saw no other bodies other than are mentioned above. He could not relate places, directions or events on the sketch and did not seem to understand the sketch. A photograph of TU was obtained. No further information could be obtained from TU.


