SWORN STATEMENT

1. ARVIL J. KIRK JR. , WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

INVESTIGATOR'S STATEMENT

On 29 December 1969, PHU was interviewed by me between 1445 - 1610 hours, in the presence of 1LT John C. WOOD, , Hq MACV, APO SF 96222, acting as interpreter. Personal data of PHU is as follows:

PHU stated substantially as follows: About 0700 hours, 16 Mar 68, she left her house at Tu Cung and went to the market at Son Tinh and returned to Tu Cung about 1200 hours. She saw no soldiers but found her house burned and the following relatives dead outside the entrance to her house. Nguyen CHI, 45, husband; Nguyen Thi CUNG, 55, mother; Do NHANH, 4, nephew and Do Thi BE, 6, niece. She also found Do TRO, 35, her brother, dead in a well belonging to a man in the village who had moved to Saigon, long before Mar 68. She stated that she saw many bodies at the main trail into the village but does not know how many. No one was there alive. She then went past a drainage ditch and saw many people in the ditch dead. She does not know how many but saw no one alive. She stated that three families had lived near her.

1. Mr. DANG, 70; Mrs DANG, 60; Pham Thi DUC, 35, daughter-in-law of DANG and Pham THANG, 10, the son of DUC. PHU states that Mrs DANG is alive in Son My but she saw the bodies of Mr DANG, DUC and THANG in the drainage ditch. 2. Nguyen Thi CAI, 45; Nguyen CAI, 40; Nguyen Thi NGUYET, 10 and Nguyen CU. PHU states that she saw these four people dead in the ditch. 3. Pham Thi OAC, 60; Nguyen KY, 45; Nguyen TRI, 6 and Nguyen CU, one. PHU states that she buried her relatives in the rice paddies near the main trail to the village. She owned two water buffaloes and two pigs. The Buffaloes were killed but she could not find the pigs. She stated that U.S. soldiers had been there twice before, dates unknown and caused no harm. They gave food to the people. PHU identified a man and two children in B & W photograph frame 34 A as Mr CHAU. She does not know the names of the children. They are at an unknown address in Saigon. B & W frame 16 A, she identified as Mr Mot LAI, whom she saw dead on the trail. B & W frame 21 A, she identified as Mr DANG from Binh Dong Sub Hamlet. He is alive and in Saigon at an unknown address. B & W frame 26 A, she identified the man in the white shirt on the far left as Mr TRO from Binh Dom Sub Hamlet, alive now in Son My. The man in the black shirt on the far left is Mr Nguyen TAN, alive now in Son My. The second man from the left in the black shirt with a white cloth on his head and squatting is Quang DU, whom she states is dead. She recognized the man in white with his back to the camera as Quang KHAI and states that he is dead. She does

you know the others. She identified colored photograph number fourteen as Mr Ba NHI, 40 and the child is his son. She did not know the name of the child. She saw their bodies along the trail entering the hamlet. She identified the woman in the red shirt of colored photograph number fifteen as SO from Son HOI, who was selling fish sauce in Tu Cung. The woman in black on the right buttoning her shirt is Do Thi CAN, 30, holding her nephew Do HAT. The lady on the left side of the photograph with the thin hair was identified by PHU as her mother Nguyen Thi CUNG. PHU states that her mother had two names, CUNG her official name and also PHU. She identified the girl with white shirt in the left of the photo as Do Thi BE, her niece mentioned earlier in this statement. She could not relate anything to the sketch and could furnish no further information. A photograph of PHU was obtained.
