## INVESTIGATOR'S STATEMENT

On 31 December 1969, NHUC was interviewed by me between 1145 - 1305 hours, in the presence of 1LT John C. WOOD, Hq MACV, APO SF 96222, acting as interpreter. Personal data of NHUC is as follows:

NHUC stated substantially as follows: About 0700 hours, 16 Mar 68, she was at her home in Tu Cung. Artillery had hit on the outskirts of the village but she does not know for how long. She heard helicopters and saw them land on the outskirts of the hamlet. She does not know how many helicopters landed, but states that they landed on the western side of the hamlet. She then saw soldiers (U.S.) come to the house next to her home. She can not remember how many soldiers were there for she was afraid. The soldiers then shot into the house of Nguyen Thi CHAC, 35 and then shot and killed CHAC and her son Nguyen Thi BOM, 8. When she saw this she hid in the bunk or within her house with her sister, Nguyen Thi CU, 11; her father, Nguyen LUU, 61; her brother Nguyen CHEM, 9; her daughter Nguyen Thi NGUYET, 6 and her son Nguyen NGA, 4. The soldiers told them to come out and all in the house except herself went out and were taken away. She then ran from the house and was stopped by U.S. soldiers and taken to a gathering at the main trail. She states there were many soldiers there but she does not know how many. Some of the soldiers, number unknown, then fired into the group with rifles. After the firing stopped and the soldiers left she got up and was not wounded. CHEM, her brother, was not wounded. She then saw her father dead and CHEM and herself ran away to Son Hoi. She returned in the afternoon about 1600 hours and approached on the main trail. There she found the body of her father and buried him. She returned and found the body of her sister and buried her. She then returned and found the bodies of her two children and buried them. All were buried in the rice paddies outside the hamlet. At the trail she saw the following relatives dead: Nguyen LIEU, 80, uncle; Nguyen DONG, 32, cousin; Nguyen Thi NHO, 28, cousin; Nguyen SONG, 28, cousin; Nguyen LIEU, 9, cousin and Nguyen Thi XI, 3, cousin. She stated that an uncle, Nguyen DOC, 75, had been wounded but was taken to the hospital by farmers. He is now alive in Son My. NHUC stated that she saw a great pile of bodies in a ditch while looking for the aforementioned relatives. She did not recognize any of the bodies and does not know how many were there. She saw no other dead persons in the village. Her house was burned and two cows and four pigs were shot at her house. She stated there were no Viet Cong in the village. U.

## STATEMENT (Continued)

S. soldiers have been to the village twice before but did not harm anyone. She has not seen ARVN soldiers in the village. NHUC identified the man in photograph B & W frame 34 A, as Mr. CHAU, 80. He is alive at an unknown address in Saigon. She identified three persons in colored photograph 16 as Do Thi CAN, 35, the person in the black shirt buttoning same; the child in CAN's arm as Do HAT, 3 and the lady on the left with balding hair as Do Thi NHU, 90. She could not furnish the names of the other persons depicted in the photograph. NHUC could not relate events and locations to the sketch. She could furnish no further information. A photograph was obtained.


