SWORN STATEMENT

I, ARVIL J. KIRK JR., WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

INVESTIGATOR'S STATEMENT

On 2 Jan 70, between 1615 - 1650 hours, THI was interviewed by me in the presence of 1LT John C. WOOD, Hq MACV, APO SF 96222. THI's personal data is as follows:

THI stated substantially as follows: He has been a Viet Cong medic for Tu Cung Hamlet for about two years. On or about 30 December 1969, he was captured near the area by U.S. soldiers. He states that he went to Tu Cung Hamlet from Binh Dong after the U.S. soldiers had left. He gave the date as 16 March 1968 and stated that he was familiar with the lunar and western type calendars. He states that he saw about one hundred or more people dead in an irrigation ditch. He treated about ten people for gunshot wounds of the head, legs, buttocks and arms. He does not know their names but stated there were three women and seven men. He also saw a group of forty or fifty bodies on the trail leading into the hamlet. He heard that a girl known only by the name NGUYEN, 13, had been raped and then killed. He stated that he did not know any names because he was from Binh Dong. He stated that about fifty people were killed in Binh Dong. He stated that the U.S. soldiers left the Tu Cung area about 0900 hours. When questioned as to the time he became very evasive with answers. He stated that there were no Viet Cong in the village before or when the soldiers came. THI could not or would not furnish any names or locations within the hamlet. No further information was obtained. *ASK*
