SWORN STATEMENT

I, JAMES APRIL JACKSON KLINK JR., WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

INVESTIGATOR'S STATEMENT

On 13 January 1970, Doan Nguyen MINH, Chief Nurse, Quang Ngai City Civilian Hospital, was contacted by 1LT John C. WOOD, , HQ MACV, APO SF 96222, interpreter and myself to examine records regarding treatments in March 1968. MINH furnished access to a log book which she stated is used to record the admission or treatment of all persons at the hospital. LT WOOD extracted and translated the following information from the book:

It could not be determined when the aforementioned individuals were released from the hospital. There was no entry at all in this book indicating that anyone was treated on 16 Mar 68. The entries in this book are in numbered sequence. The last entry for 15 Mar 68 was number 101 and the next entry is number 102 on 17 Mar 68. MINH could not offer any explanation as to why there was no entry of treatment on 16 Mar 68. She stated that all persons coming into the hospital for any type treatment must go through this section and it is possible that some are not recorded, however, it would not seem likely that a complete day would pass without any treatments. No further information could be obtained regarding treatments or admissions. There were no other persons listed on 17 or 18 Mar 68 from the Son Tinh District, as being treated for wounds.






