I, Kenneth Paul McLellan, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH.

INVESTIGATOR'S STATEMENT

On 6 Jan 70 Truong NGU revisited Tu Cung and furnished the following information which revised the statement dated 4 Jan 70 pertaining to his previous interviews. He also furnished information which revised that portion of the sketch attached to the statement which pertains to the main trail leading into the village from the coast road. This revised information was obtained through SA Arthur D. HARRIS, Interpreter, as follows:

His mothers name Pom Thi NHI should read Pham Thi NHI

His wifes name Tang Thi RI should read Tran Thi RI

His daughters name Truong Thi QUAN should read a son Truong QUAN

His daughters name Truong Thi XI should read a son Truong CHAU

His daughter Truong Thi THU is correct as reads

His brother Truong NHI is correct as reads

His brothers wife Phong Thi CHAN is correct as reads

His brother son Truong CU should read Truong Cu BA

His brothers son Truong CUNG should read Truong Cu BON

His brothers daughter Truong Thi MEO should read Truong Cu NAM, a son

His brothers daughter Truong Thi CHUC should read Truong Thi XI

A revised sketch is attached. He did not bury his children as originally stated. They were buried in a mass grave near his brother by villagers and he was told of it later that day and shown the burial site by a villager. He did not bury the wife of his brother but was told by a villager that she was buried somewhere near her home. He buried Lu Thi XUAN, female, age 45, next to where he buried his brothers family after he found her dead on the main trail.


