SWORN STATEMENT

I, James BUGLIO, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH.

This statement is intended to elaborate upon and/or clarify specific points covered during my interview of James H. FLYNN, , that are not shown in his written statement of 6 Mar '70.

Concerning the shooting of a 5-6 year old boy, FLYNN stated that this incident took place at the junction of the east-west and north-south trails at the south edge of My Lai (4). FLYNN could not fix positions of other individuals present. He stated he did not recall if a photographer was present, if MEDINA's order to "shoot him" was directed at a particular individual, or how much time elapsed between the order and the shot.

Concerning the questioning and shooting of Vietnamese prisoners, FLYNN related he could not describe the American officer that cut off the tip of one prisoner's finger, could not recall who else was present, exactly where that incident took place, nor what conversation took place between that officer and others present.

Concerning other allegations against CPT MEDINA, FLYNN stated he did not recall MEDINA and PHU jointly shooting at Vietnamese, MEDINA shooting a boy with a water buffalo, nor MEDINA giving an order to shoot an old man at or near the LZ.

FLYNN could not substantiate ROBERTS' testimony concerning the shooting of an old man, MEDINA reporting a body count of 310, nor using the words "that's all for today" or, "The party's over". X X X X X X X X X END OF STATEMENT X X X X X X X X X X X
