SWORN STATEMENT

I, Darrell E. SMITH, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

This statement is made to document the reinterview of Mr. Robert Earl MAPLES, 40 1/2 Avenue A, Freehold, New Jersey, for the purpose of obtaining additional information concerning MAPLES' knowledge of and/or participation in the Combat Assault Operation at My Lai (4), Republic of South Vietnam, on 16 March 1968.

On 13 February 1970, MAPLES was interviewed at Freehold, New Jersey and stated substantially as follows concerning his witnessing BERGTHOLD shoot and kill an elderly Vietnamese man. At the beginning of the assault operation at the west end of My Lai (4), he and BERGTHOLD came upon a hooch from which an elderly man, woman and two or three children exited. He (MAPLES) was standing approximately twenty to twenty-five feet from the entrance of the hooch and saw the elderly man come walking out. Without provocation on the part of the Vietnamese man, BERGTHOLD, at a distance of five or six feet, facing the man, shot and killed him by blowing off the top of his head with a caliber .45 pistol. The man did not appear to be wounded as he was walking and acting in a normal manner prior to the shooting.

As the elderly Vietnamese woman and the children came out of the hooch, the woman was crying and came over to him (MAPLES) and showed him that she had been wounded in the left arm. He did not know how the woman received the wound in her arm. To the best of his knowledge, the woman and the children were gathered with other villagers and marched on through the village.

MAPLES stated that he does not recall of anyone shooting into or through the hooch before or after the man, woman and children came out nor does he recall of BERGTHOLD or anyone entering the hooch at any time. He further stated that he did not enter the hooch and did not hear shots fired from within it.

MAPLES concluded by saying that he had no knowledge of BERGTHOLD shooting a wounded Vietnamese man as an act of mercy.




