## SWORN STATEMENT

I, Coy L. WELLS

, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

Between 1115 - 1200 hours, 10 Mar 70, I interviewed Pham MOT in the presence of SP6 Raymond O. WALDEN, acting as interpreter. Personal data of MOT is as follows:

 EDUCATION: 1 Year, can read and write a moderate amount

MOT stated substantially as follows: On 16 Mar 68 (given in our calendar rather than lunar calendar) he was in My Hoi at about 0900 when he saw the American Soldiers come across the bridge near My Khe. He was frightened of them and ran and hid in a <sup>166</sup>bunker. He remained in the bunker until about 1500 and then came out. He saw that the soldiers left toward the south, and that the hamlet had been burned. Crops had been burned also. He saw about 37 bodies of persons, however he did not know the names of anyone killed except for the members of his family which were killed. He buried the members of his family which were killed and then went with other refugees to the area of Son My Village, where he has remained. The names of his family members who died that day are: Le Thi HONG, 82 years old, his grandmother; Pham Thi Den, 12 years old, his female cousin; Pham BOI, 8 year old, cousin, male; Pham Thi BAY, 4 years old, cousin, female. MOT could offer no additional information and affirmed that his statement is true to the best of his knowledge and belief.






