SWORN STATEMENT

, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

Between 1430 - 1500 hours, 14 Mar 70, I interviewed Ngo Thi DO in the presence of SPC Raymond O. WALDEN acting as interpreter. Personal data of DO is as follows:

DO stated substantially as follows: On the 18th day of the 2nd lunar month of 1968, she saw early in the morning when the sun had not been up very long, helicopters circling to the west of My Hoi. She ^{saw} them come down as if landing on the other side of the water to the west. Later she saw them coming across the bridge near My Hoi and she took her children and hid with them in some thickets outside the hamlet. She did not see the Americans come into the hamlet, as she was hidden, however she heard much firing and explosions. The Americans remained in the area for about two days, however only remained in My Hoi for about four or five hours. After they left, she came out of hiding and went into the hamlet. She found many bodies, many of them in bunkers, others having been dragged from the bunkers (whether by the Americans or others in the hamlet, after the Americans left, she did not know), many with their stomachs open and their intestines hanging out. The stench was very bad. She buried her family members who were killed in the family bunker by grenades and shooting. She then went with the others to Son My Village. At Son My, a count was taken of who all had been killed and she was later told that 97 persons lost their lives that day in My Hoi. Her family had no livestock, however lost their rice crop and home in addition to the ones who were killed. The members who lost their lives were: Kho Thi AN, 60, mother; Nguyen Thi KHUYEN, 35, sister; Nguyen Thi YEN, 30, sister; Nguyen Thi HUA, 10, niece; Nguyen Thi SON, 5, niece; Nguyen DE, 8, nephew; and Nguyen Thi IE, 5, niece. She lived in Son My about a year before moving into Co Phu. DO could offer no additional information and affirmed that her statement is the truth to the best of her knowledge and memory.




