SWORN STATEMENT

I, ARVIL J. KIRK JR., WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH.

Between 1225 - 1245 hours, 14 Mar 70 Pham HANG was interviewed by me at Co Phu Hamlet, Tu Hien Village, Tu Nghia District, Quang Ngai Province, RVN, in the presence of SP5 Jeffery M. JOHNSON, acting as interpreter. Personal Data of HANG is as follows:

HANG stated substantially as follows: About 1000 hours on an unknown day in Mar 70, he was fishing about one kilometer from his sub hamlet My Hoi when he heard some shooting in that direction. He did not go back to My Hoi until about 1500 that day. He found his house burned and his mother Le Thi CHINH, age 75 dead in the family bunker. He believes she was killed with a grenade because he has since described the wounds to an unknown Vietnamese and he was told it was probably a grenade. CHINH was struck in the lower and upper body in several places. He left the area right away. On his way out he saw four bodies together outside of a home. He does not know their names but stated it looked like a mother and her three children. He did not return to My Hoi after this. There were about six homes around his own which were burned. He does not know how many others were burned. He owned no animals. He stated that Viet Cong had been in the sub hamlet three days before the soldiers came. He thinks there were just two VC cadre in the sub hamlet, but they left prior to the coming of the U.S. soldiers. HANG could furnish no additional information. He affirmed that to the best of his knowledge his statement was true.
