## SWORN STATEMENT

I, ARVIL J. KIRK JR., WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

## INVESTIGATOR'S STATEMENT

On 16 March 1970, attempts were made to locate Nguyen Thi BAY to clarify portions of her statement made to Criminal Investigator FHEER on 17 Dec 69. The records of the Quang Ngai Province Hospital, Quang Ngai City, RVN, reflect that BAY entered that hospital on 20 Dec 69 and was released to her own custody on 30 Dec 69. This was verified by Luong Thi LIEN, nurse. BAY's present whereabouts are unknown by officials of the hospital. Nguyen HUONG, a National Police representative at the hospital was interviewed. He has no record of HUONG and when shown a photograph of BAY, he was unable to recall having seen BAY. There was no record of BAY at the patients prisoner section, the prisoner interrogation center or the Quang Ngai City Prison. All efforts failed to disclose the whereabouts of BAY.
