SWORN STATEMENT

I, _____, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

INVESTIGATOR'S STATEMENT

While Chief Investigator of the Special CID Team conducting investigative operations in Vietnam during December 1969, January, February, and March 1970, I had occasion to interview Nguyen CO (also known as Nguyen Khac TUONG) on 19 January 1970 at the Chieu Hoi Center in Tu Nghia District, Quang Ngai Province. My statement of four pages in which I recorded what Nguyen CO told me is dated 19 January 1970.

I have reviewed this statement today (4 April 1970). I noted a mistake in my recording of Nguyen CO's statements to me. The mistake appeared on page 2 of my statement in the line beginning with the words "Frame 10A". The same mistake was repeated in the line beginning with the words "Frame 11A".

During my interview of Nguyen CO, he identified two of HAEBERLE's black-and-white photographs (Frames 10A and 11A of HAEBERLE's second roll of black-and-white film) as having been taken near the home of Do PHU in Thuan Yen sub-hamlet, Tu Cung hamlet, Son My Village. Nguyen CO made it clear to me during the interview that he was referring the home occupied by Do PHU on 16 March 1968 which was located in Thuan Yen about 140 feet north-east of Do PHU's second house (unoccupied on 16 March 1968).

On the map of Thuan Yen reconstructed by Do VIEN prior to the interview of Nguyen CO, the house in which Do PHU was living on 16 March 1968 was identified as House #3. Do PHU's second house, then unoccupied, was identified as House #38. In preparing my written statement on 19 January 1970, following my interview of Nguyen CO, I stated that Nguyen CO had identified the two photographs mentioned above as having been taken near the house of Do PHU marked as House #38 on Do VIEN's map when he actually identified them as having been taken near the house marked as House #3 on Do VIEN's map. Neither my interpreter, Specialist Arthur HARRIS, nor I spotted the error when we reviewed my written statement before signing it on 19 January 1970.

I have today corrected the original of my statement of 19 January 1970 to read "#3" where the statement read "#38" in the two lines on page 2 beginning "Frame 10A" and "Frame 11A". All copies of my statement already distributed should also be corrected.

The references to Do PHU's house in the two lines of page 2 of my statement which begin "Frame 17A" and "Frame 18A" correctly refer to Do PHU's unoccupied house which is identified as House #38 on Do VIEN's map.
