


BASIS FOR INVESTIGATION Investigation predicated upon information developed during the course of investigation surrounding alleged atrocities committed by former members of Co C, 1st Bn, 20th Inf, Americal Division, APO SF 96217. (CIDA-70-C-004)			
INVESTIGATIVE SUMMARY Investigation disclosed that on 16 March 1968, at My Lai (4), Republic of Vietnam, SCHIEL, HUTSON and several unidentified individuals allegedly shot and killed a group of approximately nine Vietnamese men, women and children. The murder occurred about halfway through the village of My Lai (4) during a Combat Assault Operation by Co C, 1st Bn, 20th Inf, Americal Division, of which SCHIEL, HUTSON and the unidentified persons were members of the same squad. To date, the victims remain unidentified.			
SUBSTANTIATION Mr. Dennis M. BUNNING, a former member of Co C, 1st Bn, 20th Inf, Americal Division, stated that he witnessed SCHIEL and several unidentified members of his squad shoot and kill a group of approximately nine Vietnamese men, women and children about halfway through the village of My Lai (4). Further, that he overheard SCHIEL state that he did not want to shoot the Vietnamese but had to because he had been ordered to do so.  HUTSON stated that at the southeast edge of My Lai (4), he, SCHIEL and other unidentified squad members killed a group of approximately ten Vietnamese men, woman and children.  SP4 Harold (NMN) BROWN, a former member of C/1/20, stated that SCHIEL related

SCHIEL stated that he did not shoot any Vietnamese civilians that he considered to be unarmed and acted only on the orders given him during the Combat Assault Operation at My Lai (4), RVN.

Investigation continues.
