GENERAL COURT-MARTIAL ORDER  
NUMBER 1

13 January 1970

Before a general court-martial which assembled at Fort McPherson, Georgia, pursuant to Court-Martial Convening Order Number 36, this headquarters, 14 November 1969, as amended by Court-Martial Convening Order Number 40, this headquarters, 26 November 1969, was arraigned and tried:

Private First Class (E-3) Daniel A. McCampbell, SSAN: , US Army,  
Special Processing Detachment, United States Army Garrison, Fort McPherson,  
Georgia.

Charge: Violation of the Uniform Code of Military Justice, Article 85

Specification: In that Private First Class E3 Daniel A. McCampbell, US Army, Special Processing Detachment, US Army Garrison, Fort McPherson, Georgia, then a member of 620th Transportation Detachment, Fort Sill, Oklahoma, did, on or about 11 October 1967, without authority, and with intent to remain away therefrom permanently, absent himself from the unit to which he was then attached, to wit: Headquarters and Headquarters Detachment, Artillery Aviation Command, located at Fort Sill, Oklahoma, and did remain so absent in desertion until on or about 19 August 1969.

PLEAS

To the Specification and the Charge: Not Guilty.

FINDINGS BY MILITARY JUDGE

Of the Specification: Guilty, except the words, "and with the intent to remain away therefrom permanently" and "in desertion;" of the excepted words: Not Guilty.

Of the Charge: Not Guilty, but Guilty of a violation of Article 86, UCMJ.

SENTENCE

To be dishonorably discharged from the service, to forfeit all pay and allowances, to be confined at hard labor for one year, and to be reduced to the grade of Private E1. (No previous convictions considered).

The sentence was adjudged on 28 November 1969.
