## SWORN STATEMENT

*EJM* EDWARD JOSEPH MANAK, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

I was in the breezeway of the University of Miami Library outside the Brockway Lecture Hall at 1945 hours on 5 June 1970 in Coral Gables, Florida. I was there because as an MS III cadet I was performing the duty of usher at the Army commissioning exercises of graduating ROTC cadets. I saw quite clearly Mr. Ardell Richard Faul, a lady who presumably was his wife and baby standing outside the door emptying into the breezeway. I could see him quite clearly and recognized him.

Mr. Faul was carrying a sign which encouraged other cadets to join him in refusing to accept an Army commission. I went up to Mr. Faul and asked him if he was refusing his commission. He stated that he was refusing his commission. He stated this to me. He said he would not enter active duty in the United States Army either as a Second Lieutenant or as a Private. Mr. Faul also said that he would go to prison rather than enter the Army. He said this at approximately the time of 1955 hours, 5 June 1970 at the place stated above.

I clearly saw Mr. Faul and heard him make these statements to me.
