Subj: Allowance of electronic equipment for MSTS ships in service  
Encl: (1) Electronic equipment allowance table for MSTS ships in service (USNS)

1. Purpose. This Instruction establishes and promulgates a revised authorized allowance of electronic equipment for all MSTS ships in service (USNS). This allowance includes all authorized electronic navigational aids, communications, test and measuring, and radiac equipment and systems.

2. Cancellation. This Instruction supersedes COMSTS Instruction 9670.1A.

3. Directive. Enclosure (1) is a guide for all installation and maintenance planning concerning the electronics facilities in the subject ships. This allowance does not constitute authority to accomplish any new installations, removals, replacements or equipment design modifications without the specific approval of COMSTS in accordance with COMSTS INSTRUCTION 4700.2<sup>1</sup> (Maintenance and repair of MSTS ships; administrative procedures for).
