REASONS FOR CHANGES

CMPI 610.7-6a.--Amended as follows:

(1) Deletes all reference to blowing tubes since this subject is covered in the new paragraph CMPI 610.7-6s.

(2) Increases the premium pay from \$2.46 to \$3.25 per hour during regular hours and from \$4.05 to \$5.35 during overtime hours when engine non-officers (Pacific Schedule) are required to perform the stated "dirty work".

(3) Deletes the sentence describing work below the floor plates which excluded premium pay for work which could be accomplished by reaching down from a sitting or prone position or by stepping down on tank tops.

CMPI 610.7-6b.--Increases the premium pay from \$2.46 to \$3.25 per hour during regular hours of work and from \$4.05 to \$5.35 per hour during overtime hours when engine nonofficers (Pacific Schedule) are required to perform inside spray painting.

CMPI 610.7-6c.--Rewritten to clarify the scope of duties of Wipers (Pacific Schedule) in freighters when cleaning quarters of nonofficer engine personnel.

CMPI 610.7-6l.--Increases the premium pay from \$2.46 to \$3.25 per hour during straight time hours and from \$4.05 to \$5.35 per hour during overtime hours when Wipers (Pacific Schedule) are required to clean cargo pump rooms after liquid cargoes have been worked.
