1. Purpose. This Notice furnishes the annual numerical index of effective COMSTS Instructions issued through 31 December 1968 and lists COMSTS Instructions cancelled during the period 1 July through 31 December 1968.

2. Distribution. MSTS area commands normally receive 30 copies of COMSTS Instructions. It is not intended that all of these Instructions be distributed within the immediate command but that the majority of them be stocked to: (1) fill requests, (2) fill initial allowances of newly activated MSTS subordinate shore commands or ships under their administrative control, and (3) supply pertinent Instructions to MSTS representatives. MSTS subarea commands normally receive five copies of applicable COMSTS Instructions and other activities normally receive two copies. Symbols are from the Standard Navy Distribution List, Parts 1 and 2, and Annex A to Part 1. MSTS area and subarea commands and MSTS office abbreviations are further condensed in this Notice. Only the "action" addressees are indicated except Masters of civil-service-manned ships which when "copy to" addressees are indicated at the end of the list by T-100 in parentheses (T-100). Distribution of COMSTS Instructions is made on a need-to-know basis.

3. Action.

a. MSTS area and subarea commands shall submit requests for COMSTS Instructions to COMSTS.

b. MSTSOs, MILDEPTS, OCEANOUNITS, CORSCHOPSDETS, Masters, MSTS Units, and MSTS Representatives shall submit requests for applicable COMSTS Instructions to the appropriate MSTS administrative commander.

c. Non-MSTS activities normally should request only those Instructions which include them in the distribution list but which have not been received. However, when non-MSTS activities determine by subject matter, that certain Instructions not held by them are needed they may request them from COMSTS.

4. Cancellation. This Notice is cancelled upon receipt of the next annual numerical index of effective COMSTS Instructions and for record purposes on 31 January 1970.
