1. Purpose. The purpose of this instruction is to clarify procedure
applicable to MSTS ships in reporting unidentified or hostile submarines
in the Pacific Ocean and contiguous waters under other than wartime
conditions.

2. Cancellation. MSTSPAC Instruction 3360.2 is hereby superseded and
canceled.

3. Information. Pursuant to a directive in reference (a), Commander
Military Sea Transportation Service distributed references (b), (c), and
(d) to MSTS ships in-service (USNS). These publications provide simplified
instructions and material for reporting intelligence information under
joint U. S. and Canadian procedures established by reference (e).
COMSTSPACAREA has obtained and will distribute additional copies of references
(b), (c), and (d) as necessary.

4. Directive.

a. Commissioned ships (USS) under the administrative control of
COMSTSPACAREA shall be governed by the effective edition of reference (f).

b. In-service ships (USNS) shall utilize MERINT procedures prescribed
by reference (b) in reporting unidentified or hostile submarines. In
addition to addressees prescribed by reference (b), Commander Anti-submarine
Defense Force, U. S. Pacific Fleet (COMASWFORPAC) shall be
made an information addressee on initial reports of submarine contact. WARFARE

c. All ships shall use utmost care in identifying contacts as a
submarine prior to transmitting a report. Erroneous reports can result
in unnecessary and expensive investigative searches. It is reasonable
to assume that any submarine desiring to evade closer observation can do

so. Ship's "hull down," small surface craft in the trough of a swell, whales and floating debris frequently are mistaken for submarines. Watch personnel should be required to review recognition manuals periodically to minimize cases of mistaken identity.

d. In addition to message reports prescribed by subparagraphs a. and b. above, all ships shall submit an amplifying letter report of unidentified or hostile submarine contacts, original to COMSTSPACAREA with copies to CINCPACFLT and appropriate Sea Frontier or Naval Force Commander.


