Subj: Emergency fire and abandon ship drills

Ref: (a) COMSTSINST P3120.2C, Subj: Administrative and Operating  
Procedures for MSTs Ships, Paragraph 2-8-5  
(b) COMSTSINST P12410.1A, Subj: Lifeboat Training Guide

1. Purpose. The purpose of this Instruction is to promulgate supplemental instructions relative to emergency fire and abandon ship drills conducted on board ships assigned to COMSTSPAC and subordinate commands.

2. Cancellation. MSTSPAC INSTRUCTION 3550.1E is superseded. \*

3. Action

a. Masters shall comply with reference (a), plus applicable Coast Guard rules and regulations. In ships with military departments assigned, the master shall afford lifeboat training to male members of the military department as described in subparagraph b. below. \*

b. COMILDEPTS, whose primary responsibility is to the passengers, shall ensure that their personnel are capable of launching and operating lifeboats. All male members of military departments shall receive instruction and training in lifeboat launching and lifeboat operation under the supervision of ships' licensed officers. The male members of military departments shall be exercised frequently in lifeboat operation. At least once in every three months they shall, as a group, function as a lifeboat launching crew under the direct supervision of ships' officers and shall launch the boats from one of the lifeboat stations. This shall be a station with nested lifeboats if the ship is so equipped. Lifeboat training and handling shall be as prescribed in reference (b). The extent of participation by military department personnel in abandon ship drills on board USNS ships shall be noted in the "Remarks" column of the master's monthly Training and Drill Report (MSTS Form and Report 12410-5).

4. Critiques. In order that the drills may serve as a training medium as well as an evaluation of readiness, critiques shall be held immediately following the drills in such a location as the master may direct. If space permits, it is suggested that boat commanders attend this critique. \*
