1. Purpose. The purpose of this Notice is to promulgate an inspection forecast for MSTSPAC ships for fiscal year 1970 as required by reference (a).

2. Inspection Procedures

a. Types of Inspections. In addition to the formal inspections required by reference (a) and scheduled in enclosure (1) hereto, the following informal inspections will be conducted by appropriate COMSTSPAC Staff personnel when these ships are in the San Francisco Bay area.

(1) Ships will be inspected informally during each inport period by personnel of cognizant offices and of the Chief Inspector's Office to assist in the correction of deficiencies and to ensure that progressive remedial action is being taken.

(2) Pre-embarkation inspection of troop spaces and facilities in transports and other ships carrying troops will be conducted. These inspections will normally be held the day prior to embarkation and may be attended by representatives of the shipper service and, when appropriate, by the designated voyage staff.

(3) Ships returning to or leaving Full Operating Status may be given informal material and administrative inspections as conditions warrant. These inspections, when conducted, will not be graded but will be held for the primary purpose of providing assistance to the ship.

b. Notification of Inspections

(1) Notification of date of formal inspections conducted by COMSTSPAC will be promulgated in accordance with reference (a). Timely notice of inspections conducted by other activities will be provided when firm arrangements have been completed.

(2) Normally, notification of informal inspections will be given orally.

(3) No prior notification will be given for the conduct of disbursing audits.

3. Action. Masters and Commanding Officers shall utilize this Notice and enclosure (1) as guides to timely preparation for inspections.

4. Cancellation. This Notice will be considered cancelled as of 30 June 1970.
