SUBJECT: Reporting quality complaints on merchandise received

1. Purpose. This bulletin provides guidelines for reporting complaints on the quality of merchandise received from the General Services Administration, whether from the General Services Administration supply facilities or by direct delivery.
2. Expiration date. This regional bulletin contains material of a continuing nature and will remain in effect until canceled.
3. Exception. Complaints on the quality of merchandise received directly from suppliers or manufacturers through Federal Supply Schedules should be handled as outlined in Federal Supply Catalog, "Guide to Sources of Supply and Service," Section 1.
4. Reporting procedure. Submit an original and two copies of Form R9-2051, Quality Complaint. Attached is a copy of the form. A supply of this form may be obtained by request from:
