Subj: U. S. COAST GUARD Inspection- Dec. 1967 and Manual of Vessel
Maintenance 4700.3B compliance with Figure 6-2.

1. Deck Officers listed below are hereby assigned definite items to prepare properly and submit for U. S. C. G. Inspection.
2. Deck Officers listed below will keep a written record of tests and inspections. A. M. and P. M. tests and inspections are to be submitted to Bridge in time for logging same. A progress report will be submitted to the First Officer at 1500 Hours each day. Check-off lists for the above tests are available in the Deck Office.
3. A conference will be held directly after arrival in Oakland, at the termination of current voyage and policies and plans discussed. Your suggestions will be appreciated.
4. The following duties are hereby assigned:

a. Second Officer

- (1) All navigational equipment and instruments.
- (2) Detex Clock Stations and Watch Clock records.

b. Third Officer - 104-3

- (1) All Watertight doors.
- (2) Debark ladders and fastenings.
- (3) Pyrotechnics- Bridge and Abandon Ship equipment.
- (4) Chain and Pipe Safety Rails, including their stanchion sockets and fittings.
- (5) Line gun and shoulder line guns and accessories.
- (6) Lifeboat station markings on deck and on interior of ship.
- (7) Fire axes.

c. Third Officer - 104-2

- (1) All Fire Stations
- (2) Emergency Lockers
- (3) Zonite Hi-temp. and Smoke Detecting systems, test stations, Manual alarm stations, etc.,.
- (4) Fire screen doors - check markings, hose ports, etc.,; test all doors prior to inspection; Check marking.
- (5) Ring bouys
- (6) Wolf Safety Lamps (4) - charge and have in operating condition
- (7) Shore Fire Main Connections; test valves, plugs, prior to Inspection. Check marking.
- (8) List of emergency equipment.

d. Third Officer - 104-1

- (1) All Lifeboats and Lifefloats.
- (2) CO₂ 15lb. Cylinders.
- (3) Gas Masks - O. B. A. Masks.
- (4) Debark Lights.

e. Third Officer - 104-4

- (1) All life preservers on the ship.
- (2) Life Preserver cards in staterooms and all Troop Areas.
- (3) Soda-Acid Fire Extinguishers.
- (4) CO₂ Main Bank, 45 cylinders.
- (5) Independent CO₂ Banks.

5. Necessary seamen help will be provided. The First Officer will be consulted for help and will arrange for same at the discretion of the First Officer.

6. Any tests or inspections must be witnessed by appropriate Ship's Officer.
