1. References (a) through (d) are amended to reflect certain base
pay and premium pay increases to licensed deck officers in passenger
and cargo ships under the Pacific Schedule of Wages.

2. The specific amendments are as follows:

a. A 2 1/4% increase in base pay to all licensed deck officers,
including the Damage Control Instructor rating, in all classes of
ships effective 16 June 1967. Enclosure (1) is to be substituted
for the existing page 1 of reference (a).

b. A 2 1/4% increase in the nonwatchstanding compensation. On
page 19 of reference (a), footnote (a), in the third line delete
"\$153.21" and "1966" and substitute "\$156.66" and "1967" respectively.

c. A 2 1/4% increase in the overtime and penalty time rates.
On page 20 of reference (a) paragraph II.A.1, delete "1966" in both
places and substitute "1967". Delete the amounts of "\$4.33" and
"\$3.07" and substitute "\$4.43" and "\$3.14" respectively.

d. A 2 1/4% increase in the regular compensation paid to Relief
Deck Officers. On page 22 of reference (a), paragraph III.A, delete
"1966" and "\$4.33" and substitute "1967" and "\$4.43" respectively.

e. A 2 1/4% increase in the premium rate to licensed deck officers
when cargo is being worked during overtime hours in a continental U.S.
port. In reference (b) delete "\$4.84" and substitute "\$4.95" per hour
effective 16 June 1967.

f. A 2 1/4% increase in the premium rate to licensed deck officers when required to supervise the cleaning of tanks during overtime hours. In reference (c) delete "\$5.28" and substitute "\$5.40 per hour effective 16 June 1967".

g. A 2 1/4% increase in the premium rate to Relief Deck Officers, in lieu of the regular hourly rate, during the time cargo is being worked. In reference (d) delete "\$4.84" and substitute "\$4.95 per hour effective 16 June 1967".

3. The above changes will be effected on the dates cited.
