1. Purpose. The purpose of publishing the Brig Regulations is to standardize and control the conduct and discipline of prisoners. Prisoners will read and familiarize themselves with the "Regulations Governing Confined Personnel". Failure to do so will not be an excuse in any case of delinquency or violations of regulations while in confinement.

2. Inspections. Inspections will be of two general types as follows: Regular Inspections: regular inspections will be made at periodic intervals in the interest of police and sanitation and discipline of the Brig. Surprise or "Shakedown" inspections: shakedown inspections will be made at irregular and unexpected times for the purpose of searching for contraband. These inspections will be made at the discretion of the Duty Warden.

3. Police and Sanitation. The Brig and the surrounding area are to be kept in the highest state of cleanliness possible. Clothing and personal items will be kept in accordance with current regulations, except during the hours of sleeping as prescribed in the plan of the day, bedding will be folded and triced in accordance with prescribed ship's regulations and in no case will be unfolded after 0600 or before 2045.

4. Employment.

a. Every effort will be made to keep prisoners occupied. All prisoners will work during those hours called for on the daily routine. Prisoners will normally be employed on working parties dispatched to various parts of the ship. Prisoners whom the Medical Officers designates as incapable of all employment will be given jobs equal to their capabilities. Segregated prisoners will be required to perform only such work as may be necessary to keep their cells clean and orderly.

b. The following restrictions will govern prisoners on work details: Fraternization or familiarity between prisoners and other personnel, civilian or military is absolutely prohibited and will be cause for disciplinary action against both parties. Prisoners will not perform any job which would be detrimental to their health or welfare. Prisoners will never, under any circumstances, perform any personal service for duty personnel. Any request for such service should be reported to the Brig Officer at the first opportunity.

6. Conduct of Prisoners.

a. Every prisoner in confinement will be required to perform some type of work. Prisoners who are physically unable as certified by the MEDICAL OFFICER, or whose sentence precludes employment will not be required to perform physical labor other than necessary to keep their cells clean and orderly.

b. Prisoners will obey without comment or argument the orders of officers or enlisted men in authority over them.

c. Prisoners will perform the work assigned them in a quiet, orderly, and diligent manner.

d. Prisoners will not at anytime speak to a person in authority over them except about their duties or their needs; and under no circumstance will prisoners place their hands on such person, or intentionally touch his clothes or jostle him.

e. At anytime a prisoner has a question about his status or his duties, he will address such inquiry to the TURNKEY or to the BRIG WARDEN.

f. Prisoners will not talk with the other prisoners in the brig or when they are at work except when necessary in the performance of their duties, routine talking period, or to give warning of danger.

g. Prisoners will be orderly at all times. Turnkeys or brig guards may stop all talking at anytime if it becomes too boisterous.

h. Prisoners will not engage in trade, barter or other activity with each other, persons in authority over them, or other personnel they might have occasion to encounter.

i. Prisoners will be required to make any necessary head calls prior to departure from the Brig Compartment for a work detail. Head and urinal calls will be held to an absolute minimum when outside the Brig.

j. Bedding will be handled within the Brig as directed by the Brig Officer and Medical Officer. Prisoners will not use bedding for any purpose other than sleeping; and then only during the hours for sleep.

k. Prisoners will not alter, cut or mutilate the clothing and shoes furnished him. If they do not fit, or need repairs, he will report to the Brig Warden.

l. Prisoners will not be provided with, nor will they provide themselves with any special convenience or luxuries. Each Prisoner will have the same equipment and receive the same treatment as other prisoners confined in the Brig.

m. Every prisoner will keep his person neat and clean at all times. Prisoners will shower once daily.

n. Prisoners will submit to a complete search upon initial entry into confinement and at such other times as necessary for proper maintenance of security. Prisoners will be searched upon return to the Brig from outside details.

o. Prisoners will at all times remain where they can be seen when working under the charge of a Brig Chaser. Any attempt on the part of a prisoner to hide or conceal himself from a Chaser will be immediately reported to the Brig Warden by the Chaser.

p. Whenever the command "ESCAPED PRISONER" is given, prisoners will immediately flatten themselves on the deck; arms and legs outstretched and head down.

q. Prisoners will be courteous in their manner and speech toward other prisoners and to those in authority over them.

r. Prisoners will not mark draw, paint or otherwise deface any compartment or part of any compartment or other equipment forming a part of the Brig facility.

s. Prisoners will not make insulting gestures or use indecent or insulting language, or jostle or push against another prisoner with the intention of annoying him. Prisoners will not play tricks, quarrel, or attempt in anyway to provoke another to anger.

t. Fire, Collision, Emergency and Abandon Ship drills and actual emergencies are signalled by sounding of the general alarm bells and the ships whistle and by passing the word over the P.A. system. When an alarm is sounded, each prisoner will conduct himself as follows:

1. Arise immediately (at night) and dress with a minimum of protective clothing and head covering. Don life jacket.
2. Maintain absolute silence.
3. "Fall in" for immediate evacuation.
4. On the evacuation order, prisoners will move to the outside of the Brig "ON THE DOUBLE", fall into ranks in an orderly fashion, and be escorted topside.

u. Prisoners will not hide or secrete any articles of contraband on their person or anywhere in the Brig Compartment.

v. A prisoner will not at anytime have in his cell, or on his person money, tools, cigaretts, weapons, food, or other articles not issued to him.

w. A prisoner is forbidden to sign any protest or petitions which has been signed by another prisoner. Each prisoner will make his request or complaint individually.

x. Prisoners desiring interview with the Brig Officer, Brig Warden or other officials will make known this desire by making a verbal request to the duty turnkey.

z. Prisoners will stand at attention when spoken to, and will answer questions in a military manner and in a distinct courteous voice.

aa. Prisoners will not salute. They will not cease work on the approach of an Officer unless so ordered.

bb. Prisoners will be permitted to converse in courteous and normal voice with other prisoners during messing. This privilege will be revoked at anytime conversation becomes obscene, loud and boisterous, or discourteous.

cc. Prisoners will take only such food during meals that they can consume. Wasting of food in any form will not be tolerated. "Seconds" will be permitted prisoners only after all other persons messing in the mess hall have had the opportunities to partake of food. Seconds will be permitted only with the permission of the Duty Warden.

dd. Solitary or segregated prisoners will not engage in conversation at anytime. Segregated prisoners will not sleep during normal working hours. They will remain in complete uniform of the day at all times unless permission is obtained from the Brig Officer to alter the uniform.

7. Trustees.

a. A limited number of trustees may be designated by the Brig Officer.

b. These prisoners will be chosen from those persons exhibiting superior attitude and outstanding conduct while confined.

c. Trustees will be allowed to work within the Brig Compartment without supervision. Except for all the formations they will be exempt from normal prisoner requirements in regard to movement within the Brig Compartment. They will be allowed during this period to have head and water calls whenever they desire. Exemption from normal prisoner requirements in regard to movement within the Brig Compartment expires at 1830 daily.

d. At no time will a trustee exercise or attempt to exercise any authority over another prisoner.

e. These privileges will be revoked at anytime if the Brig Officer detects misuse or abuse of them or upon any deliberate infraction of Brig Regulations. Trustees are still prisoners and will be treated as such except for the specified times mentioned above.

8. Department and Conduct.

a. Prisoners are required to comply fully and willingly with all regulations and orders. The only instance when a prisoner is justified in refusing to carry out an order is when the prisoner's life will be endangered. If at any other time the prisoner feels the orders of the duty personnel are improper he will comply with the orders and report the matter to the Brig Officer using the means mentioned above.

b. The Commanding Officer, Military Department and the Senior Unit Commander are authorized to award courts-martial and to take certain administrative disciplinary measures against persons confined in the Brig for misconduct prejudicial to good order and discipline, or violation of Brig rules and regulations. One or more of the following measures may be taken against a prisoner for cause:

- (1) Reprimand or warning.
- (2) Deprivation of one or more privileges
- (3) Extra police duty.
- (4) Disciplinary segregation on regular rations on restricted diet.
- (5) Trial by Court-Martial

c. The Brig Officer is authorized by the Commanding Officer, Military Department or the Senior Unit Commander to impose certain of the above mentioned measures for cause.

9. Clothing, Equipment, and Personal Property.

a. Upon initial confinement, prisoners will be clothed in their utility uniform. Prisoners are furnished and will wear on the left sleeve of their uniform a white armband.

b. Toilet articles, writing materials, changes of under clothing, etc., will be maintained in a clean and orderly manner in the Brig Compartment.

c. Each prisoner is furnished sufficient bedding and it will be the duty of each prisoner to maintain this equipment properly.

d. Prisoners will be permitted to expend personal funds held in safekeeping for such items as toilet articles, writing material, etc., not to exceed \$3.00 per voyage, except upon approval of the Brig Officer. Purchases will normally be allowed only one time each week.

e. Prisoners will not be permitted to retain in their possession, money, jewelry, or other personal property with the exception of essential clothing, toilet articles, wedding rings, religious materials, eyeglasses, dentures, and a reasonable number of inspected personal letters, and approved photographs.

f. Prisoners will upon initial entry into confinement be required to surrender all items they are not authorized to possess to the duty Brig Warden who will prepare a receipt listing such items in detail. This receipt will contain both the signature of the prisoner and of the Brig Officer. One copy of this receipt will be given to the prisoner for retention by him while confined in the Brig.

10. Health and Sanitation.

a. Inspections will be made daily, including Sundays and Holidays, of the Brig by the Brig Duty Personnel, and by such other personnel as are designated by the Commanding Officer, Military Department.

b. The Brig will be maintained in a constant state of cleanliness.

c. Prisoners are required to wear a complete set of underwear at all times.

d. Prisoners will be clean shaven and hair will be neatly cut at all times; mustaches and beards are prohibited.

e. Prisoners complaining of ill health at times other than the 0800 sickcall will be afforded an opportunity to visit the sickbay.

f. Prisoners suffering any injury at anytime while confined at this Brig will report same in writing to the Brig Warden at the earliest opportunity. This applies to minor injuries such as small cuts, burns, or bruises as well as injuries of a serious nature, which will be reported to Brig turnkey or guard immediately. Failure to report injuries will be cause for disciplinary action.

11. Correspondence and Visitors.

a. Letter writing is considered a privilege and it may be suspended as administrative disciplinary measure for misconduct of prisoners.

b. Prisoners outgoing mail will be inspected by the Brig Officer under conditions provided by law. Prisoners incoming mail will likewise be inspected before delivery to the prisoners. Prisoners will not receive incoming mail unless they grant the Brig Officer permission to inspect their incoming mail in writing.

c. Prisoner's mail incoming or outgoing will be rejected if it contains any of the following:

- (1) Obscenity, lewdness, threats, or blackmail or contraband.
- (2) False and malicious or libelous information about individuals or officials.
- (3) Discussions of the character, offense or personal habits of prisoners, or gossip about another prisoner.
- (4) Illegible writing, not clear, wrongly addressed, or containing references, innuendos, or codes.
- (5) Enclosures which violate existing regulations.


d. Prisoners desiring to use language other than English in their quarters will first seek and obtain permission from the Brig Officer. Such requests are approved contingent upon the availability of interpreters.

e. Visitors will normally be limited to half hour visits and will be allowed on Sundays and Holidays only.

12. Religious Services and Privileges.

a. Prisoners will be offered every opportunity to attend Church Services of their respective faith consistent with security.

b. The Holy Bible and other Religious Material is available to all prisoners.

CHAPTER 3

SECTION C - EMERGENCY DRILLS AND EMERGENCIES

3-C-1 Emergency drills are held aboard ship to acquaint passengers and crew with their duties and assignments. All drills are made as realistic as possible and conducted as though an emergency actually existed. Absolute quiet is a must at all drills. No smoking is permitted during drills.

3-C-2 The COMILDEPT is responsible for the instruction and participation of passengers in drills and for their direction, control and safety during drills and in actual emergencies.

3-C-3 Passengers are instructed to dress adequately for the weather, properly adjust life preservers, and remain in their quarters unless otherwise directed. Generally, passengers participate only in Abandon Ship drills. Every person, unless excused by the ship's Doctor, must participate in Abandon Ship drills. All personnel must wear a head covering at this drill.

3-C-4 In announcing drills being conducted, the phrase "This is a drill" is used to avoid unnecessarily alarming passengers.

3-C-5 The following signals are used:

a. FIRE AND EMERGENCY: Sounding of one long blast on the ship's whistle supplemented by ringing of the General Alarm bell for ten seconds or more, followed by passing the word over the P.A. System.

b. ABANDON SHIP: Seven (7) or more short rings and one (1) long blast on the ship's whistle, and the same number of rings on the General Alarm bell, followed by passing the word over the P.A. System.

c. NBC ATTACK: Prolonged ringing of the General Alarm bell for not less than ten (10) seconds followed by short and long rings on the General Alarm bells for at least another ten seconds.

d. MAN OVERBOARD: Three (3) long blasts on the ship's whistle and the same number of rings on the General Alarm bell followed by passing the word over the P.A. System and then 3 long rings and blasts repeated.

e. SECURE: Three (3) short blasts on the ship's whistle and the same number of rings on the General Alarm bell is the signal to secure from all drills, followed by passing the word over the P.A. System.

3-C-6 Procedures for Troop Passengers:

a. When FIRE AND EMERGENCY is sounded, report to respective compartments, put on life jackets and remain in compartment unless otherwise directed. No smoking.

b. COLLISION: If COLLISION is announced as part of the General Drills being conducted, all personnel in charge and all troops will proceed as for Abandon Ship when the word "Collision" is passed. Do not wait for any other signal. No smoking.

c. When ABANDON SHIP is sounded, report to respective compartments, put on life jacket, head covering, and adequate clothing for the weather, proceed briskly to abandon ship station on deck when directed by Compartment Commander, and line up in ranks facing the sea. No smoking.

d. When NBC ATTACK is sounded all troop passengers will go to and remain in respective compartments. All passengers must remain in the interior of the ship. Eating, drinking and smoking is prohibited. In the event the ship and personnel are contaminated, troops will be directed to decontamination stations.

e. MAN OVERBOARD: All troops will report to compartments for muster.

f. Troop routing to weather decks for emergency and drill purposes are as follows:

(1) COMPT 1 (Brig): Proceed up to forward weather deck, (01 Deck) using ladder at Frame #26 (forward of compartment), fall in facing the sea on the port side, forward of ladder house. Prisoners will remain under Brig Officer Guard Control during drills or in an emergency.

(2) COMPT 2: Proceed up to forward weather deck (01), using either ladder at Frame #45 or ladder at Frame #55. Line up in ranks facing the sea near ladder house at Frame #45.

(3) COMPT 3: Proceed up to forward weather deck (01), using either ladder at Frame #65 or ladder at Frame #72. Line up in ranks facing the sea near #3 Hatch (Frame #76).

(4) COMPT 4: Proceed up to 01 deck (cabin area) level of ladder at Frame #85, proceed to open deck at 01 level by a right turn, down passageway to first crossing then onto open deck, then left again and proceed to forward troop weather deck. Line up in ranks facing the sea on the starboard side. Keep clear of #2 motor boat.

(5) COMPT 5: Proceed up ladder in #5 Hatch at Frame #156 to 01 weather deck. Proceed aft and down ladders to after troop weather deck. Line up in ranks port and starboard side facing the sea.

(6) COMPT 6: Proceed up to after troop weather deck, using ladder at Frame 177. Line up in ranks facing the sea.

(7) COMPT 7: Proceed up to after troop weather deck, using ladder at Frame #182. Line up in ranks facing the sea.

(8) COMPT 8: Proceed up to after troop weather deck, using ladder at Frame #199. Line up in ranks outboard of Chapel House facing the sea.

g. During Abandon Ship or Collision Drills or emergency, the Chief Master-at-Arms, MILDEPT will take station forward on the troop weather deck and the Chief Ship's Serviceman will take station aft, each to maintain control and to assign troops to boats if required. Only if and when directed, troops will utilize ladders over the side and embark into the boats after the boats are waterborne. The number of troops assigned to each boat will depend on the size of the troop lifts. The loading must be carefully regulated to assure that boats do not exceed rated capacity. The scale on the next page will serve as a guide.

h. The primary duty of the Voyage Staff during emergencies and emergency drills is control of troops. Compartment Commanders shall report to respective compartments for troop control and evacuation if evacuation is necessary. The Brig Officer shall report to the brig, release prisoners and bring them topside under guard. The remainder of the Voyage Staff shall take stations as the Senior Unit Commander directs. Assignment of additional NCO's to assist in controlling troops on weather decks is required.

i. During Abandon Ship drill, Military Department Troop Escorts will report to each compartment to assist Compartment Commanders in briefing their troops and will lead the Compartment NCO followed by the troops over the evacuation route to their Abandon Ship Stations on decks. Troops must move briskly, but not run. The Compartment Commander will insure that all personnel are evacuated and will be the last man out. All troops will be aligned facing outboard with the first rank along the safety lines that parallel the rails.

3-C-7 The regulations in this Section pertaining to Troop passengers are information and for strict compliance. No deviations will be allowed without the approval of COMILDEPT.
