

## Statement of Understanding on Issuance of Alcohol Ration Card, General Order 1A and Wing Policies

I understand and acknowledge that pursuant to AUABI 32-6007, General Order 1A, Wing Policies and squadron policy that:

1. I cannot consume more than three alcoholic beverages per day - a day ranges from 0900 hours until 0200 hours the next day.
2. I cannot transfer, give or sell my allotted alcoholic beverages or my alcohol ration card to another member or organization; and I cannot transfer or save any unused portion for another day.
3. I will only drink alcoholic beverages in approved locations, currently limited to the Desert Lounge (DEL), Memorial Plaza and Royal AF Officer's Club at the CAOC; and I understand that I cannot possess, consume, use, introduce or take any alcoholic beverages to any other place on or off base, to include dorms, tents, billeting, work areas, or dining facilities.
4. I must show proper identification (alcohol ration card and military/DoD civilian or contractor ID card) each time I purchase alcohol and be at least 18 years old.
5. I cannot erase, deface, or otherwise tamper with any alcohol ration card.
6. I cannot have any alcoholic beverages sent to me or obtain alcoholic beverages from a source other than through 379 ESVS authorized activities or the Desert Eagle Lounge or Royal AF Officer's Club.
7. I cannot possess more than one alcohol ration card.
8. I cannot allow anyone else to use or attempt to use my alcohol ration card to acquire alcohol.
9. I cannot use or attempt to use another member's alcohol ration card to acquire alcohol.
10. Replacement alcohol ration cards are not available unless my old card is presented; and only my commander or first sergeant may approve the issuance of a replacement alcohol ration card that is lost or stolen.
11. Prior to out-processing, I must return my alcohol ration card to the First Sergeant.
12. I cannot possess, introduce, transfer, sell, create or display any pornographic or sexually explicit material, including material that describes or shows nudity, or sexual or excretory organs.
13. I must possess a military/DoD civilian or contractor ID card at all times, whether in military uniform (DCU or flight suit), authorized PT or civilian clothing; and I must conspicuously display my military/DoD civilian or contractor ID card when in PT or civilian clothing on Al Udeid AB – for military members, my military uniform or PT clothing is the only authorized wear on base.
14. I cannot travel off base on Friday or Saturday unless for official duties as authorized by my commander; and I must request and obtain permission for any off base travel IAW AUABI 10-6008.

\* AUABI 32-6007, allows permanent party personnel, i.e., PCS, in the grades of E-9 and O-5, or above, to possess and consume alcoholic beverages inside assigned living quarters, and to consume alcoholic beverages off base during authorized morale trips. *All other rules, including the three alcoholic beverages per day limit on consumption, apply.* \*\* Except sexually explicit material obtained from AFRTS, AAFES or MWR within the AOR or downloaded off the AUAB media server during off-duty time.

### PRIVACY ACT STATEMENT

AUTHORITY 10 U.S.C. 8013

PRINCIPLE PURPOSE: For informing members of relevant rules and regulations, accountability and accounting of the issuance of alcohol ration card, and the good order, discipline and morale of the U.S. Armed Forces deployed in the AOR. SSN is used for positive identification.

ROUTINE USES: Acknowledgement of rules and regulations concerning alcohol, off base travel and GO 1A, and the good order, discipline and morale of the U.S. Armed Forces deployed in the AOR.

DISCLOSURE: Voluntary Failure to provide acknowledge or complete information will prohibit issuance of alcohol ration card or off base travel authorization or additional training on rules and regulations.


