This is the fourth in a series of Medal of Honor Recipients. Americal Division- Vietnam

Michael J. Crescenz K.I.A.

Rank and organization: Corporal, U.S. Army Company A, 4th Battalion, 31st Infantry, 196th Infantry Brigade, Americal Division. Place and date: Hiep Duc Valley area, Republic of Vietnam, 20 November 1968. Entered service at: Philadelphia, PA.

Born: 14 January 1949, Philadelphia, PA.

Citation: Cpl. Crescenz distinguished himself by conspicuous gallantry and intrepidity in action while serving as a rifleman with Company A. In the morning his unit engaged in a large, well-entrenched force of the North Vietnamese Army whose initial burst of fire pinned down the lead squad and killed the 2 point men, halting the advance of Company A. Immediately, Cpl. Crescenz left the relative safety of his own position, seized a nearby machinegun and, with complete disregard for his safety, charged 100 meters up a slope toward the enemy's bunkers which he effectively silenced, killing the 2 occupants of each. Undaunted by the withering machinegun fire around him, Cpl. Crescenz courageously moved forward toward a third bunker which he also succeeded in silencing killing 2 more of the enemy and momentarily clearing the route of advance for his comrades. Suddenly, intense machinegun fire erupted from an unseen, camouflaged bunker. Realizing the danger to his fellow soldiers Cpl. Crescenz disregarded the barrage of hostile fire directed at him and daringly advanced toward the position. Assaulting with his machinegun, Cpl. Crescenz was within 5 meters of the bunker, when he was mortally wounded by the fire from the enemy machinegun. As a direct result of his heroic actions, his company was able to maneuver freely with minimal danger and to complete its mission, defeating the enemy. Cpl. Crescenz's bravery and extraordinary heroism at the cost of his life are in the highest traditions of the military service and reflect great credit on himself, his unit, and the U.S. Army.

Your Vietnam Editor recently learned of a new organization made up primarily of men who served with the 11th Light Infantry Brigade. They're called the Hill 411 Association, named after a fire-base they worked off of in Nam. Their third annual reunion will be held on July 19 & 20, 1986 in Oakbrook Terrace, Ill. The Hill 411 gang also is expecting a strong presence at the Welcome Home Parade in Chicago this June. Ill be visiting their hospitality room to gather some more information on this outfit and hope to have an article for the next newsletter. One of our Associations newer members, Rick Savinen, (A Co 2/1st Inf 196th Bde), is currently a patient at the VA Hospital in Northampton, Mass. Rick will be leaving the hospital soon and plans to make a visit to the Vietnam Memorial in Washington but he is urgently in need of some help locating the names of former Americal comrades who were killed at LZ Judy on or about August 25, 1970. Rick indicated that a Chinook helicopter carrying approximately 35 grunts from D Co 2/1st was hovering over the LZ when it was shot down. He watched the men fall to their death and 3 more men from A Co were also killed by the rotor blade of the Chinook. Two minutes earlier he had been in a chopper in the exact spot of the disaster. Rick would like to know the names of the men who were killed so that he can pay his respects to them at the "Wall". He is also seeking information on his former CO, 1st Lt Richard Anshus. In late September or early October, 1970, the Lt was surveying the company's forward area in a Loach helicopter when he was shot down and captured alive by the NVA. If anyone has knowledge of the Lieutenants activities or whereabouts after his return to the States, Rick would appreciate the information.

Americal Division Veterans Association member Wayne P. Wilson has been elected Chairman, Secretary of the Allied Council of New Jersey Veterans Organizations. The Allied Council representing the almost one million veterans in New Jersey, is comprised of all the major vets organizations in the State of New Jersey.

Wilson served with the 176th Assault Helicopter Company in Chu Lai in 1968-69 and with the 1/20th, 11th Light Infantry Brigade in Duc Pho and the 3/21st, 196th Light Infantry Brigade in Danang as a Platoon Sargeant in 1971.

Also, Wilson credits well known Association member Dave Greiger with swooping down out of the sky on February 28, 1969 and rescuing him and four other crew members from almost certain capture by the NVA. Thanks Dave!

HAVE YOU SIGNED UP A BUDDY ?

The following article on well known ADVA member, Dave Greiger, is reprinted from "The Vietnam Veteran", a Nam vets newspaper down in Gastonia, North Carolina.

When Dave Greiger returned from Vietnam, he didn't let any grass grow under his feet. He added 2,120 flight hours to his already impressive 980 combat hours flying helicopters in Nam.

He joined the US Parachute Association and is credited with 1,120 parachute jumps. He also holds a license as a qualified jumpmaster and instructor. When parachuting became tame, Dave went scuba diving. So now he's a recognized licensed scuba diver.

Today Dave is known throughout the US for his top quality Vietnam related products. But the former pilot who had two helicopters shot down by enemy fire traveled a long hard road before he met success.

Born in Fremont, Ohio, he was drafted into the Army in 1966. After his basic at Fort Benning, he was selected to Infantry OCS. After OCS he had Rotary Flight Training and was then assigned to the 176th Assault Helicopter Company, the "Minutemen". Dave flew 980 combat hours bringing Americal soldiers into battle. He is credited with rescuing a fellow air-crew from the battlefield.

After Vietnam in October 69, he went to Camp Wolters, Texas as a flight instructor. In Nov. 72, he was back at Fort Benning. He completed the advanced Officer Infantry Course and went Airborne. On the way he earned a B.S. Degree in Aeronautical Studies and was graduated Magna Cum Laude. With the rank of Major, everything was coming up roses. But on November 19, 1978, a near fatal accident ended Daves promising military career. After years of rehabilitation and speech therapy, Dave is back on his feet, in business for himself, selling Vietnam related products.

Maj. Kenneth R. York, operations officer for the 2nd Infantry Brigade and 70th Training Division headquartered at the U.S. Army Reserve center here, died in an automobile accident Tuesday night (January 28) while returning home from a meeting at the headquarters.

Police said York's car collided with another car driven by a 23-year old man on M-59 at U.S. 23 in Livingston County at 10:22 p.m. according to Livingston County sheriff's deputies. York, 39, lived in Highland.

26 March 1986

Forty-one years ago this morning I was worried that I would get my ass blown off! But I did return!!

The Last Beachhead may not be good literature but it is word for word from my diary. The pictures were taken over Cebu City, the day we landed. Sometimes my memory fades but if I remember, John Hill and Hdq. Btry. of the 221st F.A. was on the same L.S.T. with the 125th QM Co.

THE LAST BEACHHEAD

From the bridge with the commander of our LST we could observe at approximately 0700 hours, the cruisers and destroyers pounding the area around Talisay. The shelling continued for about an hour and then the rockets started hammering the beach. The entire area was covered with gray smoke but in the distance we could see the capitol of Cebu resting against the foothills west of the city, which appeared to be burning.

At 0800 hours with two regiments abreast, (132d-182d) the Americal hit the island five miles southwest of Cebu City with no sign of opposition from the Japs - this could not have happened six months ago.

In a short time, the reports from the beach started coming back. Numerous Japanese land mines had halted the first wave and a stalemate developed on the beach. The assault units could not move safely through the mine fields until mine detectors were brought in. A log jam was developing as other troops poured ashore. For some unknown reasons, the Japs were not defending the beach. Once paths were cleared through the mine fields, the assault units were able to advance on the city through abandoned Jap positions.

Dave Hayes and Dick Powell and I went in about 0900 for the purpose of locating places to put ration and gasoline dumps and establish a truck park. We met General Ridings on the beach who was pleased that we came in early and he briefly explained the situation.

The beach was completely covered with crude mines - any type of shell the Japs could get their hands on - concealed under pieces of boards. The initial amphibious vehicles had taken a terrific beating. Many casualties and the immediate problem was to clear the beach and establish a temporary cemetery. Sent word out to Joe Larkin on the LST to bring in the Graves Registration section and our service platoon.

When Larkin came in, a small plot was selected for the cemetery, but it turned out to be some spot - again covered with mines. With the help of our engineers and others, casualties were buried. Most of the casualties were badly cut on the legs, the results of the mines.

After locating a good bivouac, we brought the truck companies in. Supply dumps were located in a coconut grove just off of the beach on the road between Talisay and Tanke. Mines again bogged us down for several hours, but we were soon handling the rations and gasoline as rapidly as they could be unloaded from the LST

THE LAST BEACHHEAD (Continued)

After a sleepless night on the beach, and a can of "C" rations, I started out early the next morning, (March 27), with Nick and John Vierea to locate a spot for a forward gasoline supply point.

We met Johnny Watt's battalion (182) just before they shone off for Pardo, a small barrio halfway to Cebu City. We went along with them as far as Basek, where we found a good place for our gasoline supply point. Johnny Watt told us that Franco's outfit (132) had reached the edge of the city. We returned to the unit and started gasoline moving forward to Basek.

This afternoon, our second on the beach, Walt Vertner from the G-4 office and I started to visit the gasoline point. We found it operating O.K., so we decided to push along further down the road towards Cebu City. The road had been mined for its entire length with large size aerial bombs, poorly concealed, sharpened bamboo stakes, and barriers built of logs and earth.

Near Mambaling, we met General Ridings who told us that booth Franco and Dahler (132) had reached the City and that Bucky Harris (182) was swinging inland towards the Capitol headed for the Lahug Airfield. We continued on to the city and swung down toward the docks. Again the road was mined but poorly camouflaged; they were easily spotted.

The first place I recognized from my map was the Bank Building and the Shamrock Hotel. The bank was not badly damaged but the hotel was a shell. Walt and I proceeded cautiously along the dock area. The piers seemed to be in good shape and could handle six Liberty ships at a time. Several Jap ships were sunk off the seawall but ships could be brought in around them.

Opposite Pier 3, we met Franco and Dahler, who were taking a break before pushing their battalions up through the city to meet Bucky Harris near the airfield.

Scouting the area opposite the docks we located several reasonably intact warehouses that could be utilized for storing rations and other supplies.

The Cebu Trade School was claimed as quarters for the company and location fo Division QM Office. The next morning (March 28) the company under Bill Ulbricht moved up from the beach, settled in, commenced operating and all prayed that this would be the Americal's Last Beachhead.
