AFFIDAVIT OF JOHN MCRATNEY

I, John McRatney, under penalty of perjury, state upon personal knowledge as follows:

1. I reside at _____, Bedford, Texas

2. In the summer of 1987 I was a Douglas DC-8 pilot for Rosenbalm Aviation. Rosenbalm had a contract with Emery Air Freight to fly domestic scheduled cargo services on behalf of Emery.

3. I have reviewed my contemporaneous personal flight records for the period which included July 5, 1987. These records show that I departed San Diego on July 3, 1987 on Flight No. 003 and flew a scheduled routing which took me to Ontario, California and Dayton, Ohio. From Dayton, I flew on Flight No. 069 to Newark, N.J. where I arrived on July 4, 1987. I stayed at the Holiday Inn in Newark. Commencing on July 6, I flew the reverse routing to Dayton then to Los Angeles and to San Diego arriving on July 7.


4. I have never been an employee of Southern Air Transport, Inc. although I occasionally flew aircraft operated by the Southern Air Pacific Division in the 1960's when I was employed by Air America.

5. I am not licensed to fly an L-100 or the military equivalent C-130 and I have never flown this aircraft type.
