When I submitted my family file to ODP in Bangkok, my family members are:

- Bui Thai Hung	my son <i>Sinh ngày 20/10/74</i>

Bui Thi Ngoc Hue, my daughter was not called for the interview on 10/24/95 in Vietnam because she was over 21, and after the interview, Bui Thai Hung was denied because he had 4 days over 21 years old at that time.

My two younger daughters, my wife and I were approved to enter the U.S. and we are living at the above address. Our family were separated, we are suffering about that. We pray and hope one day we can be reunited in the U.S. My two children are still living in Vietnam without any source of support and without our supervision. They sent us many letters to express that they wanted to join us as soon as possible, that they couldn't undergo any more the situation in Vietnam which they had to cope with.

Please Mr. Pendergrass, according to McCain amendment, my two left behind children are eligible to come to live with us, have them processed complying to law, they are:

-Bui Thi Ngoc Hue (10-16-72) Passport Pt 1/91.Dc1, Hanoi 3-11-91
-Bui Thai Hung (10-20-74) Passport Pt 1 0/91.Dc1, Hanoi 3-11-91
