I, CAO THI CAN, DOB July 19, 1925, residing at the above address, hereby formally apply for resettlement in the United States of America for reunification after years of separation due to the 1974 Exodus.

I am sponsored by SIRM NGUYEN (a/k/a Tinh Thi Cao, Cao thi Sinh, Cao thi Sinh Nguyen) of Piscataway, NJ 08854, USA - (1-75/ Form (a)).
I have been authorized by the Vietnamese Government to exit to the USA - IP Exit Permit granted, name placed on List NO 2/421 (no. (a)).

I am unmarried and all of my siblings have left or are scheduled to leave Vietnam for the USA or France :
1- my oldest sister and sponsor Cao thi Sinh is living at Piscataway, NJ, USA ;
2- my younger brother Cao Nguyen Anou, formerly Lt-Col. of the ARVN is living in France after being released from a concentration camp;
3- my younger brother Cao Nguyen Anou, formerly Artillery Col of the ARVN, was released from Concentration camp in 1991 and his name has been placed on list NO- / to be interviewed;
4- my younger sister Cao Thi Luan has been interviewed with her husband Le Sim Ngo, a former Engineer Col. of the ARVN on list II 14-400.

I will, therefore be the last of my family to remain in Vietnam.

Kindly do me the favor of considering my application as a companion to that of my brother Cao Nguyen Anou (nr 3 above) who has applied for admission to USA.

Please take note of this application and consider us superseded my letter submitted on Aug. 12, 1992 (no. 2)
