I request that ODP chack the case according to case number provided above and confirm for me that the daughter and her family listed qbove are eligible and part of group that ODP is now contac-ting to invite to interview. If a new letter of introduction has ready sent, I would appreciate thatyour office knowing the date it was sent and to what address in Vietnam. That will help me ensure it arrives.

I appreciate taht your office is busy with many case, but my family and I are equally anxious to ensure that the case of our children be reconsidered under the new law before their eligibility expires.
