It is also requesting your favorable consideration be given to my Request as special humanitarian cases: We came to SVN as Refugees since 1954, now after the events of April 1975, although with a lot of difficulties my family still lived with a normal life but we were not get used to the situation and, as for the future of my children, aged from 3 to 13 years old. Even though they did with the best with their learnings at school they will not be able to go farther than secondary school...due to ~~the~~ duties performed and close associated with USG's activities in SVN during the past.
