- Ngày 25-8-1993, gia đình tôi được Sở Ngoại Vụ mời đến phỏng vấn làm thủ tục xuất cảnh, sau khi phỏng vấn viên chức phỏng vấn không chấp thuận cho vợ tôi là TRAN THI THO và con gái của vợ là LE THI HOANG YEN được cùng chúng tôi sang định cư tại Hoa Kỳ.

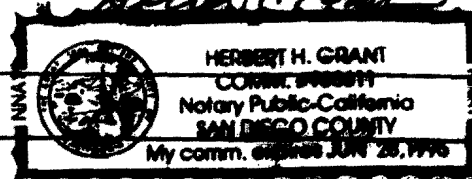

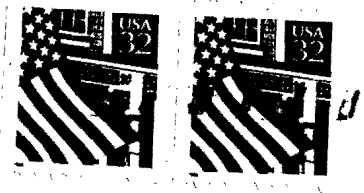
