**RE: SON'S IMMIGRATION STATUS**

Dear Mr. Phenderjerss,

I am Tuan Anh Do, immigrated to the United States Of America by Human Operation Program (H.O 21-676) since 1993. My present address is , Hapeville Georgia 30354

I am writing you this letter to request for your reconsideration the case of my son Phu Dinh Do. Who would be eligible to come to the United States with me and my family since 1993, but still remain in Viet Nam

On March 2nd, 1993. I and my three daughters and my son Phu Dinh Do were called to be interviewed by the D.O.P Officials in Ho Chi Minh City, Viet Nam. On that day my son (Phu Dinh Do) was so unprepared and nervous, He could not be able to prove with the D.O.P Officials that he is my son, and he was denied the right to come to America with me.

Actualy, when I was held as a prisisoner in VietCong Reeducation camp, my wife was in serious illness and the family was so poor. My son (Phu Dinh Do) had to go to work far away from home trying to find money to support the family. His name was eliminated from the list of family register, an not to be recognized as a member of the family by the Vietcong Distric Officials.

I was tempted to appeal to the D.O.P Officials to reconsider my son's case. But I was seriously sick during that time, and needed immediate medical treatment. So I left Vietnam Without my son.

Now I am better, but old, weak and disable. My wife has been dead since 1983, my daughters are married, I need my son here to take care of me. I now have all documents and pictures that can prove Phu Dinh Do is really my own son.

I am looking forwart to hearing from you soon. Thank you for your time and consideration. While I am waiting, Please accept my gratitude and appreciation.
