Due to the difficulty of my situation and based on the authority of the Organization in which thousands of people have been saved by your humanitarian act, I wish to call your assistance, and your intervention with the Government of the Socialist Republic of Vietnam in order that my family as below , be permitted to leave Vietnam under the protection of the Organization, and to immigrate to the United States of America for the purpose of family reunification and for the sake of our interest :

Dear Sir ,

I wish to call your attention to my own circumstance :

1/ Being a former Officer of the VN Armed-Forces, I was sent to the United States in 1964 for schooling 2 courses : PO Course # 1/65 at FT BRAGG - N.C. and CA Course at FT GORDON - GA .

2/ Retired in 1967, I was, as US Government employee, working for the Voice of Freedom from June 67 to June 71. My assignment was Chief of Administrative Department (Admin. Officer) my last grade/level was VGS 12/2 . I would like to enumerate the names of some American counterparts to prove this I used to collaborate with : MM. MICHAEL DALE BROWN, LOUIS M. STEED , EARL WAYNE BRYANT, JOSEPH R. CREGER .

I resigned VOF on July 26, 1967 and worked for SAIGON Bank from July 71 until 30th April 1975 .

On 24 July 1979, I have submitted an application for classification as refugees, composed of my family and I listed below, to be immigrated to the United States , to HCR - Office of the United Nations - 140 Lausanne Geneva 10 - SWITZERLAND .

Recently, I am informed by a brother of mine (whom I take his name up as sponsor and is living in the United States) that the US Government approves our immigration on condition that he has to provide us an Affidavit of Support. The fact is, my brother could not do any support for my family and I, so my application must be suspended .

Taking my antecedent into consideration, I greatly beg you to see my family and I through 2 points :

- to review the former approval of Washington of our immigration whether it is still available .
- to classify my family and I as refugees under your program and grant us a letter of Introduction in order that we may process our exit-permits with the authorities of Vietnam .

I would highly appreciate receiving from you any help and information related to my request .
