I would like to report to you the followings,

My children have told me that, in the interview
on March 16th, 1999, at the ODP-Office in Ho Chi Minh
City - Vietnam - they have been accepted to resettle in
the United States of America (MC CAIN Program) --
all of them seven (7) persons as followed:

- CHAU HOANG NGHIA - born on April 17th, 1958 - son
- CHAU THI YEN TUYET - " August 13th, 1959 - daughter
- LY THANH HOANG " June 15th, 1958 - son-in-law.
- LY CHAU HOANG TUYET PHUONG " January 14th, 1997 - grand daughter
- CHAU BUI HOA " January 1st, 1962 - son
- CHAU HOA HIEP " November 8th, 1965 - son
- CHAU BUI SA HIEN " December 30th, 1973 - son

After that, all of them (7 persons) have undergone
a medical examination at the "April 30 Hospital"
in Ho Chi Minh City and have recently had the
vaccination (the second time).

They have lately contacted:

- The ODP Office in Ho Chi Minh City
- The International Organisation for Migration (IOM) Office in Ho Chi Minh City

And these offices have let them know that they have finally been accepted, all of them seven (7) persons as mentioned above, in order to resettle in the United States of America, and they will leave Vietnam approximately in August 1999.

On July 6th, 1999, I received the information from the USCC of St Petersburg - Florida - USA, that there are only 6 of my 7 children in the verification list.

My youngest son's name is CHAU BUI SA HIEN born on December 30th, 1973, has been missing from the list.

I am requesting for my youngest son CHAU BUI SA HIEN mentioned above can be able to reunite with us, his parents and with all his brothers and sister, in the United States of America.

Please allow him, my youngest son CHAU BUI SA HIEN, to leave Vietnam at the same time with his brothers and sister.

My family and I thank you very much for your assistance in this important matter.
